#### Stated Clerk Report March 7<sup>th</sup> & 8<sup>th</sup>, 2017

- 1] Welcome to Session 72 of Classis British Columbia North West. A big thank you to the council and members of Immanuel CRC for their hospitality in hosting once again the Spring meeting of classis BCNW.
- 2] The agenda for this meeting will keep us busy with ministry reports and presentations, an address by CRCNA Executive Director Dr. Steve Timmermans (Wednesday morning), updates from the classis renewal and going forward team, presentation from The Tapestry on the Marpole Church Plant and Mundy Park merger, a proposed communication for Synod 2017, a proposal for a new commissioned pastor position, the template completed for the new societies act for the churches, Tuesday evening workshop on church visiting lead by Rev. Cecil Van Niejenhuis, nominations as well as all the regular classis work and committee reporting.
- 3] As stated clerk I have engaged in numerous emails, telephone calls, conference calls, correspondence, reports, meetings, dealing with requests and information from pastors and councils, continual updating functionaries lists, web site updates and organization, organizing marriage registrations for new pastors in our classis as well as some temporary registration numbers for visiting pastors, set the examinations in place and assigned the various teams needed for these examinations, organized CMC agenda material and lead meeting, recorded executive minutes, set agendas, recorded and distributed classis minutes and regular administrative duties on behalf of classis. Other work done includes spending time on forwarding announcement emails, denominational and government communications, etc. to churches, committees, and others as required.
- **4]** On January 17<sup>th</sup> and 18<sup>th</sup>, the stated clerks from each of the 12 Canadian classes as well as one classis leader met in Burlington, Ontario for a time of sharing, information, workshops with the staff of the Canadian office and Canadian Ministries Director, Rev. # Classical Ministries / Interim Committee Report to Classis BCNW: Session 72 March 7<sup>th</sup> & 8<sup>th</sup>, 2017

The classical Ministries committee does most of its work by email conversations, phone calls and conference call meetings. Meetings were held on Dec.5<sup>th</sup> and January 30<sup>th</sup> where several key issues were discussed and items planned for the agenda of this classis meeting.

#### 1] CMC Actions

- Reviewed and approved expenses from classis meeting in October 2016 \$ 9194.21
- Appointed Rev. Curtis Korver to serve as the next chair of classis and Rev. Ken Vander Horst as Vice-all.
- Rev. Chelsey Harmon will serve as recording secretary.
- The AGM of the Classis BCNW Corporation will take place at this meeting of classis. *note: agenda and pertaining documents will be included with the classis agenda package.*
- Dr. Steve Timmermans, executive Director of CRCNA will address classis on the Wednesday morning session and allow time for some Q&A.
- Rev. Cecil Van Niejenhuis will lead classis for the Tuesday evening session in giving a workshop on Church Visiting. The goal of the workshop would be to encourage a fresh appreciation for what church visiting could be and become as we consider being a healthy community of churches who are better together than alone.
- appointed two members of the CMC (Andy & Kathy) to begin discussion on looking at the two sides of the CMC, administrative and missional and putting some structure to the concept of aligning with the new mission's statement and make it workable for churches looking for classis help in local missions and outreach ministry programs.
- appointed a "Carry Forward Team of Rev's. Albert Chu, Trevor Vanderveen, Andrew Beunk with CMC members Kathy Smith and Andy de Ruyter
- \* team to look at renewal in connection with what Synod committee is working on, agenda setup, ministry reporting, days and times we meet, length of meetings (including how many times per year) where we meet, overall costs and cost projections for future, regional classis meetings, ministry shares etc.

Team would be mandated to survey each church council for input.

Also how to incorporate into classis meeting, interviews and ministry highlights from churches

just to name a few items this group could look at.

- asked the Seafarers Committee to engage in doing a full scale review with outside participants for ministry in light of the retirement of their current Chaplain in September 2017. Review to include ministry objectives, relevance, staffing, budgets, projections etc. Review to be completed before a search for a new chaplain is to begin.
- received a communication from Nanaimo CCC on the Belhar Confession for Synod 2017. (refereed to pre-advice overtures committee) *note: copy of communication included in the agenda package*
- BCNW Rules of Procedure updates. CMC appointed Rev. Ken Vander Horst (with CMC help) to begin work on updating and reviewing our current ROP. Work has begun on reformatting, updating, re-writing etc. Ken will present an update to this classis meeting.

- CMC has initiated a review of how the pre-advice committees for classis function with the goal of updating mandates and procedures. Possible appointing sitting committees instead of current practice.
- Celebration of the 500<sup>th</sup> Protestant Reformation. We have invited BCSE to join us for the Tuesday evening session which will mean we have to move our meeting dates to Oct 17<sup>th</sup> & 18<sup>th</sup> from the 3<sup>rd</sup> & 4<sup>th</sup>. Will have dinner together and time for fellowship, then a worship service with a speaker on how the reformation defines us today. BCSE also wants to commemorate the 90<sup>th</sup> anniversary of CRC within BC. Possible meeting sites: New West CRC or Fleetwood CRC. (details to be worked out with a co-classis team after approvals received)
- CMC has asked staff from The Tapestry to do a presentation on their ministry in light of their church plant in Marpole and merger with Mundy Park CF. Presentation to include explanation on ministry outlook, structure and governance etc.
- CMC has asked CRCM (UNBC) to present their review of this ministry to classis. Rev. Andrew Aukema will present of behalf of the board. note: a copy of review included in the agenda package
- Ms. Caroline Short, classis Regional Disability Advocate will lead classis during the Wednesday morning session on the Mental Health Taskforce (5 min pre info, 15 min video presentation, 5 min questions / comments)

## Nanaimo Christ Community Church A Communication to Classis

The Council of Christ Community Church wishes to encourage Synod 2017 to recategorize the Belhar Confession to that as the same status of a contemporary testimony in the CRC.

We believe such an act shows due respect to, and cooperation with, our ecumenical faith partners, who have expressed confusion at its current status as an "ecumenical faith declaration." We also wish to respect and listen to the voices of our own diverse family who have asked for a reconsideration because of the way they have been transformed in identity, purpose and belonging by the Belhar Confession, along with their hopes and prayers for the transformation of our world by Christ through the church.

Along with providing more clarity to others about what we believe, the Belhar Confession is helping our congregations reflect, repent, and be "renewed in knowledge according to the image of its creator" (Col 3.11) in ways that the other creeds, confessions, and testimony have not.

Understanding what true unity is within the church, how to work for reconciliation with one another for faithful witness to the world, and seeking justice for our brothers and sisters in Christ are realities that are confronting us every day. Like the unity that it espouses upon, the Belhar Confession represents both a gift and an obligation to the church-a characteristic it shares with our confessions and contemporary testimony. Though these challenges have existed for as long as sin has been part of this world, we recognize them as pressing and timely, while also admitting that we can be too overwhelmed to discern how the Holy Spirit is leading us to Christ's call to action. The Belhar Confession proclaims both the call and the action by helping us to envision not only what to believe, but what to do.

This Confession has the power to be used by the Holy Spirit to deeply shape us as a church for faithful witness in the 21<sup>st</sup> century and we agree with others who have called for the reexamination of its position in the CRC. Such a re-examination is a true sign of humility and a desire to seek the will of God. From our own recent discernment and study of the Belhar Confession, we believe it will be most beneficial to the church if it is made one of our contemporary testimonies rather than keeping it as an ecumenical faith declaration. The church knows how to relate to and use our current contemporary testimony; the same cannot be said for an ecumenical faith declaration.

Though we did not write the Belhar, as brothers and sisters in Christ, we *can* proclaim this call of Christ and express the unity of faith, of which Christ is the cornerstone. (Eph 2.11-22)

On behalf of Nanaimo Christ Community Church,

#### <u>BCNW - Safe Church Team Ministry Report</u> Safe Church Ministry Needs Assessment (MNA) – Summary

13 BCNW churches participated (out of 17) & 13 in BCSE totalling 26 churches in British Columbia

WHERE WE ARE AT: 8 goals for Safe Churches

- 1. That every church has a council appointed representative on the Classis Safe Church Team. <u>Some</u> churches have council appointed reps on the SCT most leaders unaware of who or the role
- 2. That every church has a Safe Ministry Practices team at the local level. In the <u>2 BC CLASSES COMBINED</u>: 7 CHURCHES have OFFICIAL local church safe ministries teams & some churches have a couple leaders working together to try to ensure safe practices happen.
- 3. That every church has written and implemented their own Safe Church Policy.

  100% OF THE BCSE PARTICIPATING CHURCHES had a safe church policy and in every participating church there were either *numerous or many* participants that indicated they had not seen or read the policy. ALL THE CHURCHES INDICATED THEIR POLICY NEEDED UPDATING and in many cases it has been 5 or many more years since it had been updated.
- 4. That every church regularly accesses training for their staff, leaders and volunteers. Participating leaders listed areas of training needs. RESULTS WERE ACROSS THE BOARD.
- 5. That every church leader is actively committed to safe church practices within their area of ministry

Participants shared specific ways in which their respective ministries implement safe ministry practices. <u>EVERY CHURCH</u> INDICATED THEY NEED A LOCAL SAFE MINISTRIES TEAM to provide support, oversight and training to raise the level of leaders' commitment to safe ministry.

- 6. That every church uses a Safe Church curriculum specifically designed to train, guide, and empower children & youth with regard to their personal safety.

  BCNW participating churches had not yet started using Faith Alive "CIRCLE OF GRACE" program to educate children & youth about their personal boundaries & safety. By participating in the MNA leaders became aware of this program and its recommended use.
- 7. That every church has become a place in which everyone feels that she/he can raise issues of abuse without fear or shame.
- Participants shared the <u>SAME COMMON CONCERNS</u> that prevent persons from coming forward or raising the issue of abuse without fear or shame. These concerns included, fear, shame, threats, judgement, disbelief, failure to be understood, lack of knowledge, lack of trust in leadership, lack of safety...
- 8. That every church council has knowledge of, and follows approved protocols for, responding to allegations of church leader misconduct.

Participants <u>ALL</u> indicated the need to follow approved church protocols in responding to leadership misconduct or abuse allegations. <u>ALMOST ALL</u> council members indicated they had not participated in a council training and also indicated they saw a need for the training.

### PARTICIPANT EVALUATIONS OF THE IMPORTANCE OF THE 8 GOALS TO (their) MINISTRY

MNA PROCESS BENEFITS – communicated by participants:

- > The opportunity for round table discussion. Some ministry groups indicated it was the first time they had a ministry team discussion focused on the abuse prevention concerns of their ministry.
- > Created a stronger communal/team approach to safe ministries.
- ➤ Helped leaders to identify the gaps. (All local Safe ministries teams indicated this was helpful.)
- Enhanced working relationship with the classis SCT and the APRC.
- > Showed the areas of need for training. Commonalities in this need were very clear.

#### COUNCIL COMMENTS INCLUDED:

"This was a real eye opener. I had NO IDEA how little I know about how much I need to know."

"We need to grapple with underlying issues connected with Safe Church – the roots of abuse."

"This process has shown us where we need to pull up our socks."

"Our council has decided to adopt the 8 goals and work with them."

"We need help to refresh this ministry."

"As Chair of council my eyes have been opened and we really need to get our house in order." "Our council needs to communicate & work more with the classis SCT ministry and the APRC."

Boundaries – What does every leader need to know?

Youth Ministry Roles & Issues
Risks of Ministries/Offsite Activities

Seniors – Vulnerability, Safety & the Church's RoleSupport for Policy Implementation

## Council of Delegates of the Christian Reformed Church in North America

The **purpose of the Council of Delegates** (COD) is to govern entities and activities of the Christian Reformed Church in North America (CRCNA). In fulfilling this responsibility, the COD shall

Transact all matters assigned to it by synod and serve in the interim of synod with matters which cannot await action by the assemblies themselves . . . and submit all such actions to the next meeting of the assembly for approval.

Lead the integrative ministries of the CRC in light of the Mission, Vision, and Callings established by synod, providing recommendations to synod when the Missions, Vision, and or Callings need to be reconsidered.

Cooperate with the educational institutions affiliated with the denomination and World Renew as well as other CRCNA boards toward integrating the respective missions of those institutions and functions into the denominational ministry program.

Provide an intermediary role that serves three purposes: (1) To receive and understand input from congregations and their members (constituents), (2) bring the work and excitement of ministry to congregations and their members, and (3) understand the church—its various contexts and times—to such a degree that the COD assists in casting an appropriate vision for the future growth of the church.

The **mandate** requires the following policy development responsibilities for the COD. The COD shall

Provide appropriate financial management and advance policy guidelines and limits within which personnel function, thereby ensuring the financial integrity of the denomination's agencies and ministries.

Identify when necessary, evaluate regularly, and support constructively administrative leaders of the denomination within the scope of policies.

Provide the criteria (goals) and evaluation of progress toward goals for the unified ministry of the CRC while establishing the contours (policies) within which personnel pursue such goals. Attend to the organizational structure and health of the denomination by developing policies of assessment (e.g., Ministry Plan counts and measures; personnel surveys, etc.), reviewing outcomes, and addressing goals and policies as needed.

Because of the significant size in its membership (52 total), the COD will require the work of committees. The current plan is for the appointment the following seven committees: Executive, Congregational Ministries, Global Missions Ministries, Mercy and Justice Ministries, Support Services (Finance and Facilities), Ministry Plan and Communication Services, and Nominating Services. Each delegate will serve on at least one committee. Committee membership will be based on fit between the delegate's experience and interests and the mandate of the committee.

**Responsibilities** of individual COD members include the following:

Attend all COD meetings in order to carry out required duties; attend committee meetings, and other special functions and events as appropriate; contribute to and review the agenda and supporting materials prior to board and committee meetings.

Attend classis meetings, listening to the concerns and desires of the classis on behalf of the COD, and bringing reports to the classis of the work of the CRCNA's agencies and ministries.

Pray for the CRCNA—its leaders, agencies, and ministries—on a regular basis and challenge

others to pray as well.

Give to the work of the CRCNA according to how God has blessed, and challenge God's people also to give.

Support and encourage CRCNA personnel with words of appreciation.

Participate in the assignments of the Nominating Committee (especially by assisting the classis to identify nominees when COD member's term is nearing completion).

This year, BCLDN, under the leadership of Wilma Vanderleek, is providing Reformed Leadership training to 17 participants.

One Saturday each month they gather together at Fleetwood CRC for a time of worship, engaging the scriptures, large group discussion, small group sharing and prayer, learning about a historical figure in Church History, and developing a new ministry skill. This year the focus is on the Old Testament, and several leaders have come to provide their insights on specific topics.

BCLDN is thankful that there are so many gifted leaders within the Reformed community who are willing to spend a Saturday morning or afternoon and share their knowledge with the students. This year Julia Vanderveen, Dennis DeGroot and Martin Contant have shared insights on Biblical interpretation, leading a Bible Study, giving an overview of the Old Testament, discussing the prophets, talking about conflict and reconciliation within the church and a variety of other subjects. Towards the end of each school year, the BCLDN participants go on a two-day retreat. This year the retreat is planned for April 7-9. This is a special time as they spend two days in the Word and in fellowship together.

The last session for the 2016-2017 year is in May and will be a celebration for those who have completed the three years of Leadership Training Network. This year Betty Beukema, Angela Elliot, Rick Garrison, Joe Tolkamp and Michelle Veeneman will graduate and be ready for deployment. For each participant, deployment looks different. For some it may be leadership in their church or parachurch community and for others it may mean focusing their gifts and passion in a particular area of ministry. Our hope for all of them is that they will have confidence that God has a plan and a purpose for their lives, and that the training they received at LDN will give them the knowledge and skills they need to serve wherever God may call them.

For the first time, BCLDN is offering an alumni retreat. When speaking to graduates of BCLDN, many of them mention how they miss the monthly gatherings, going deep into the Word, the small group time, and the fellowship they formed during their time at LDN. Alumni are being invited to a retreat on March 7-9 at Rivendell. Please encourage the graduates in your local churches to attend this retreat.

In addition to the 3 year Saturday program, BCLDN also offers LTAs (Let's Talk About... workshops). There are 7 topics that churches can choose from, with a new one added each year. Since September a few churches have hosted an LTA workshop:

- Nanaimo CRC together with Diaconal Ministries hosted Let's Talk About... Mentoring and Relational Leadership and
- Prince George CRC hosted Let's Talk About... Busyness and Healing Our Divided Lives.

Most of the money that BCLDN receives from the classis goes towards wages for our facilitator and administrator (just over \$36,000 in 2016). The largest expenditure after wages is the cost of materials for the Saturday LDN sessions (\$3500 books, \$1500 food, \$1200 honorariums for the guest speakers, and \$1000 in office supplies). This year the retreat cost less than budgeted as the students did not go away on a retreat as usual but instead used the retreat time to attend John Coopers's conference on same sex issues, and discuss how theology impacts our understanding of our world.

BCLDN is grateful to both classis for the support it receives. We are committed to our mandate:

- providing a 3-year curriculum that integrates Biblical content, ministry skill competence and character development.,
- providing Biblically grounded leadership workshops for CRC elders, deacons and other ministry leaders on a variety of topics and
- receiving input and encouragement from classis.

We are also thankful for our facilitator, Wilma Vanderleek, our administrator, Marion VanDriel, and our committee members, Andrew Aukema, Mike Koot, Carolynne Tolsma, John Messelink, and Joanna DeVries. Most of all, we are thankful to our Heavenly Father, for his amazing love as shown to us in his son Jesus Christ, and communicated to us in his Word. We trust that He who began a good work in us will carry it on to completion.
