- explained new agenda set up and how it works
- reported on video conference meeting with fellow Canadian Stated clerks, touching on setting Canada wide guidelines for ministry student funding, sharing resources in obtaining corporation status for other classes, understanding the new provincial society act and how that applies to the local congregation, elder and deacon training opportunities and the Salaam Project.
- advised classis that we still need a nominee for the World Renew Board for our classis
- noted Synod requirement that church visitor teams need to be one minister and one other ordained person. This is different than our R.O.P. and will be changed accordingly.
- noted church visiting scheduled and encouraged churches that have not as yet made their visit that it needs to be done by March 1, 2016.
- reviewed 2015 ministry share numbers and reminded churches that 50% of shares were due by July 1st.

CMC approved the spending of \$2000.00 for the setup of the Faith Care Workshop and approved the spending of \$800.00 for office equipment for the coordinator.

Following review of report, discussion from delegates on their council’s advice on logistics and overall costs of sending three delegates per church. Consensus on maintaining two delegates per classis, one minister and the second either an elder or deacon.

Motion to maintain practice of sending one minister and one other office bearer per church to each classis meeting.....MSC

Selection of Synod’s Delegates:

Motion to support Synods recommendation to delegate one minister, one elder, one deacon and one other office bearer.....MSC

Motion to have the minister position appointed by way of rotation for ministers who have not ever been to a synod meeting.....MSC

Discussion on the fourth delegate position involves how to incorporate a second minister delegate or leaving open to any one of the offices. CMC charged with coming up with a clear way of deciding the fourth delegate.

Classical Treasurers Report: Mr. David Pel

- presented the June 30th Financial Statements
- reviewed several of the schedules and answered questions/comments
- advised classis on the ongoing discussion on working agreements with classis ministries and/or incorporating them. CRI matters involved as well as BCSE as we share some concerned ministries with them. Will be attending a meeting with reps from BCSE and lawyers in early November.

Pre-advice Overtures Committee Report: Rev. Ken Vander Horst reporting

Five recommendations from the Overtures/Advisory committee given:

- 1] That Classis take considerable time for prayer concerning our administration and stewardship of Classis resources—both financial and personnel—prior to decision making on new funding requests, approval of budget, and determination of 2016 Classical ministry share.
- 2] That Classis identifies key values for classically supported ministries. The denomination has identified “5 Streams” for prioritizing and focusing its ministries. Classis could develop its own streams, and/or incorporate those of the denomination to aid in discerning the fitness between a ministry request and classis’ support.
- 3] That Classis develops a rubric for prioritizing the allocation of resources. This could include criteria that give precedence to:
 - Existing ministries;
 - Church planting and church based ministries;
 - New initiatives that cannot be undertaken without classis support;
 - Ministries that have developed plans to work towards sustainability;
 - Ministries that faithfully provide reports detailing the faithful stewardship of resources (classis was informed at a recent meeting that such practice is now required as per CRA’s regulations concerning charitable status);
 - Ministries that have classis-wide impact (and beyond).
- 4] That classis identify and pursue new funding models (e.g. A shared student fund with Canadian classes) that may streamline and/or enhance stewardship of resources
- 5] That classis form and mandate a standing committee to investigate how classis will apply the values and rubric to new requests for funding, and to existing funding

commitments. The committee can bring recommendations to classis meetings, and budget models based on them.

Motion to table discussion and refer to the CMC for further study and recommendations to the next classis meeting.....MSC

Safe Church Team: Ms. Faye Martin pg 19-23

Update on visits with congregations who participated in the Ministry Needs Assessment

After declining the idea of having one joint Classical executive, there were calls for new members for a BCNW team.

Faye reports to the CMC in the interim while there is no BCNW Executive

Encourage those congregations who do not yet have Safe Church Teams, to do so by March 2016

Kwantlen Multi-Faith Coordinator and Chaplain: Rev. Sam Lee pg 31/32

Albert Wu shifted his focus from Richmond Campus to pastoral ministry for the Tapestry. Requesting a reduction of ministry share to \$1 per member.

Sam Lee and Gary Roosma hold office hours on Tuesdays and Thursdays, and are involved in ‘Noontime Concerts’.

Surrey campus installed Ethan VanderLeek with support from Fleetwood CRC at 20 hours/week.

Student Fund Committee & CMLT: Mr. Victor Chen

Student Fund is depleted and the need for increase ministry shares is warranted. Proposed raising from \$10 to \$12 per share with more increases in future years quite possible.

Students are very appreciative for what they receive. One student specifically is requesting potentially another support cheque in early 2016.

Visits being planned to Regent in Spring and ACTS Seminary in Fall for information and contact lunches with seminary students.

Change Church Order to now specify matters affecting congregations who are participants of two denominations.

Recommending Belhar Confession to churches

Reinstate practice to include women advisors to Synod.

Elder Neil Roos from Mundy Park CF reports that council is exploring significant questions around steps forward for rejuvenation with the Tapestry with new insights for the future.

Leadership Development Network Proposal, pg. 23-25, addendum p.16

Rev. Andrew Aukema summarized past development, including:

- (1) LDN becoming a standing committee
- (2) explored how to promote leadership training at Classis “providing Biblically-grounded leadership workshops for CRC elders, deacons and other minister leaders”

Proposed Ministry Share increase over the next three years:

- (1) recognized current work of facilitator is 35% rather than the present compensation of 25%
- (2) proposal fulfills the task to lead “Mini-portable LDN” workshops
- (3) and to expand LDN in other areas

Affirmation of LDN and “Let’s Talk About” events

Questions from floor:

If we increase capacity, can we be sure it will meet the demand?

Possibility of a one year budget request raised and then re-evaluate?

Shouldn’t the local church own and drive the leadership development and fund their own training as needed?

Funding proposal: \$18,000 for 2016, \$24,000 for 2017, and \$30,000 for 2018

Proposed ministry share per member would be \$7.50 for 2016, \$10.00 for 2017, \$12 for 2018

Also noted planning for calling candidate Janina Mobach into bi-vocational ministry with downtown friends.

World Missions – Mrs. Ko Spyksma

Shared encouraging stories and called Classis to be sure to have a global perspective in BCNW vision. Ko also shared, one ministry, one focus “that all will see Christ.”

UNBC Campus Ministry: pg. 30-31 Rev. Alan VanderWoerd

Shared an update on UNBC Campus Ministry, including calling various Chaplains and facilitating three Christian groups on campus.

Highlights: Compassion Fatigue & Vicarious Trauma and healing strategies.

LDN follow-up proposal: Rev. Andrew Aukema

Presented a follow up proposal to increase funding (\$21,000.00 or \$8.00 ministry share) so that the facilitators salary can better reflect the true amount of hours needed to do this ministry work and to allow for paid prep-time for “Let’s Talk About” events, plus an allowance for a part-time administrator.

Proposal would not include satellite locations or going to 5 churches.

Discussion on clarity for Ministry Shares, employment issues and possible incorporation.

MOTION that BCNW support LDN for \$8 ministry share (\$21,000.00) to support the work of Leadership Development for 2016.....MSC

note: even though classis approved of additional funding, questions that need further answering on employment matters, incorporation matters, working agreements etc. will need to be worked out. Also because this is a shared ministry with BCSE, final approval will need to be worked out with what they decide to do.

CMC will continue to work with both LDN and BCSE to come to a reasonable and workable solution. New motions may be required at the March 2016 Classis meeting.
