3.1 Stated Clerk – Highlighted written report on pgs. 3-6

Noted that 2015 marks 30 year anniversary for our Classis.

Noted reports from Service Link, World Renew and M2W2 sent as attachments with the agenda

Reported on the Stated Clerks Conference in January at the Burlington CRC office. Rev. David Salverda also attended on behalf of the CMC.

Review of 2015 Ministry Shares and reminded delegates that 50% of Classical Ministry Shares are due by July 1st of each year.

Noted the newly assigned Church Visitors schedule for 2015. Noted that 15 out of 18 visits were completed in 2014.

Please remember to submit a written report of each visit, sharing it with the visited church and the Stated Clerk.

## Motion to approve the work of the Stated Clerk......MSC

3.2 **Classical Ministries Committee**: pgs. 7 - 10 & Addendum Report pgs. 4 -5 The Stated Clerk presented on behalf of the CMC.

Noted important information regarding our joint session with Classis BCSE. If any delegate is interested in the material from the Stated Clerk's & Classis Leaders Conference, reports and highlights can be sent electronically.

The CMC noted a good resolution to matters between Rev. Peter Lim and Immanuel CRC. Rev. Lim is now officially retired.

CMC processed a temporary marriage license request for Rev. Jan Wieringa (retired CRC and Gereformeerde Kerk minister)

CMC held the AGM for the Richmond CRC board in relation to the continuing transfer of the building assets to the Tapestry.

Noted reports to be given at this meeting of classis: Ministry Funding Review Report, Classis Review Team, report on feasibility of a joint executive for SCT, LDN report on expanding its mandate and standing in our classis, request for support for a Collaboration Opportunity for Ministry to International Students etc.

CMC recommends any churches seeking to form a Commissioned Pastor position to review and follow Church Order Art. 23 and contact stated clerk for help in procedure.

#### **Commissioned Pastor Requests**

1] Rev. Walt Vanderwerf presented to Classis Duncan CRC's desire to hire a Leader of Congregational Life as a Commissioned Pastor position.

5 years ago, Duncan CRC hired Henry Vanderschaaf for a part-time role and asked him to complete the Leadership Development Network (which he has now completed).

The job description, as found in the agenda, was presented for discussion and approval.

Discussion noted that this position was put together with a particular person in mind; this can be helpful so that his examination is geared towards his tasks and gift sets.

It was noted that the job description was very comprehensive and should be a blessing to the Church along with the person.

Specific to the job description, it addresses definite needs in every church (even if it was shaped with a particular person in mind).

Concern was expressed about the time commitments noted in the job description; clarification was provided about expectations of the church and how things have worked in the work relationship thus far.

Synodical Deputies Rev's. Bert Slofstra, Rich DeRuiter and Bert Pols concur with our Classical decision.

CMC will take appropriate Church Order steps for the examination, and setting up mentorship.

**2**] Rev. Tim Sheridan presented to Classis Maple Ridge CRC's desire to have a Youth Pastor as a Commissioned Pastor.

After the previous Youth Pastor stepped down, Maple Ridge spent 12-18 month time of discernment, seeking to develop a position that would make for a sustainable youth ministry. The result was the job description being presented to Classis for approval.

The Job description, as found in the Agenda, was presented for approval and discussion.

Discussion expressed appreciation for the purpose of the position.

Synodical Deputies Rev's. Bert Slofstra, Rich DeRuiter and Bert Pols concur with our Classical decision.

CMC citing church order advises classis Mr. Rozeveld was ordained previously as a commissioned pastor in Alberni Valley CRC by our Classis. Alberni Valley gave a positive statement to his doctrine and life, which allows us to not repeat a classical exam.

**Motion to** approve that Mr. Shane Rozeveld not be re-examined and give Maple Ridge CRC permission to ordain him as Commissioned Pastor......MSC

#### Re-ordination under church order art 14e

Classis received a request from Mr. Daniel Devadatta for re-ordination under C.O. 14e. Mr. Devadatta was released "Honorably" by BCNW in 2002 under CO 14b to continue in ministry in India. He recently has returned to the United States and has taken a position with the Hope Network in Grand Rapids and needs to be ordained to fulfill the terms of this position. As we are the classis who released him, under c.o.24e we need to have a non doctrinal interview with him to see if he can be declared eligible for call in the CRCNA.

CMC tried to get Classis Grand Rapids South to do the interview as Mr. Devadatta will be called by one of their churches and lives in their area. All though this is a bit outside of regular church order procedure, it had the blessing of our synodical deputies and the support of Rev. David Koll, our denominational candidacy director. Classis GR South decided not to accept our invitation to do this and so our classis will need to hold the interview. Instead of holding a full classis contracta, which would be considerable expense and time, CMC asks classis if a committee could be appointed to hold the interview with Mr. Devadatta and the synodical deputies, and be given the authority to declare him eligible for call upon sustaining a successful interview. The interview than could be done by conference call with 6 persons (3 pastors and 3 from CMC) on the interview team, the 3 deputies and Mr. Devadatta. Following some discussion and clarification, classis deemed this worthwhile and passed the following motion:

The conference call will be open to any interested delegates. Stated Clerk will notify the delegates / churches of when the interview will take place (early April?) It is noted that if the subcommittee finds something troublesome in the interview, and they cannot proceed with a declaration they will bring this back to a full meeting of classis.

Mundy Park Christian Fellowship requests classis to approve early retirement for their pastor, Rev. Albert Westerhuis at age 65, as of May 31<sup>st</sup>, 2015.

#### Continuing with CMC report:

CMC continues to be challenged to come up with a plan for the Church Development Team. They ask for Classis' patience and continue to request for help and ideas. We need people with a passion and understanding of this work and the challenges classis faces in the future. Team to explore if classis should be continuing to church plant or turn their attention to helping the local churches with their own membership issues and developing growth ideas. In the interim, CMC will continue to oversee all of the Administrative/Budget roles for our current ministries.

CMC noted the number of reports being made to Classis at this session and mentions that CMC is looking at the idea of developing a Ministry Fair to partially replace our reporting system. Please share any ideas with the CMC. Also each ministry / board/ committee presenter has been asked to make their reports brief and pointed as to what is relevant to classis and to develop ways to better communicate their reporting directly to the local churches.

CMC notes the number of written reports that will not have verbal presentations with them and ask the delegates to make them available to their churches. CMC notes that Classis BCNW is now a registered member of the Canadian Council of Christian Charities.

CMC advises that discussion continues about the schedule of our classes meetings so that it better corresponds with BCSE and presenters.

Stated Clerk also notes that a new Agenda is coming to our next meeting!

#### 3.3 **Treasurer Report**

Treasurer David Pel presented the 2014 Financial Statements to Classis and took questions during the presentation. (note: a copy of these statements are included with these minutes.)

The Treasurer notes that he did not receive the denominational ministry shares information at the time the reports were generated; he will redo the report when accurate information is received. As a Classis, we are actually supporting at about 2/3 of the budgeted amount.

Schedule 3 shows that our Classical Ministry Shares are doing well in meeting commitments.

Schedule 5 shows us out of deficit, which means we will have a ministry reduction for the Expense Fund.

Schedule 13 shows that we will need to increase support of this fund or decrease the amount we give to students.

Schedule 11 shows a cost for Church Development Team Meetings. \$15,000 of that amount was moved to Schedule 19 for Breakthrough Ministries.

Schedule 15 continues to show a healthy balance, which is available for churches in need of financial resources for things like counseling for accused as well as victims. It is also noted that there is an Interim Abuse Prevention Coordinator who is on contract with our Classis and is paid out of this fund.

## **Classical Ministry Funding Review**

Classical Ministries listed on Schedule 1 of the financial reports are a mixture of registered charities and those who fall under the Classis umbrella. As Classis is now a registered charity, we have had to review how we administer funds. In working with the Canadian Council Christian Charities (CCCC) has resulted in a plan to bring our activity into accordance with rules and regulations of CRA; the process is outlined in the proposed notice.

Motion that Classis issue the Classical Ministry Funding Review notice to each of the ministries of Classis BCNW......MSC

Treasurer David Pel will serve as Classical representative through this process.

# 8.4 New Westminster CRC proposal for Coordinator of MOSAIC and Campus Connections p. 20

Rev. Andrew Beunk presented a proposal for a part-time staff position at New West CRC focused on building relationships with area CRCs to encourage and collaborate with them in developing and strengthening local ministries to international students and scholars. He shared why this is a strategic gospel opportunity.

Home Missions sees this position as a way of creatively doing chaplaincy work on university campuses.

World Missions sees this position as a way of connecting students with missionaries when they return to their home country.

20% of the position is envisioned spent visiting and encouraging students to connect with local international students.

The ministry will report to classis annually, but this is a New West ministry. Yuri, a leader in the Mosaic ministry at New West CRC shared about the ministry's focus on having an open door and spiritual growth.

Proposed financing arrangement (per annum):

New West CRC - \$12,500

Classis BCNW - \$7.500

CRHM & CRWM - \$5,000 (\$2,500 each)

Total: \$25,000

Discussion expressed support for the proposal, especially for the synergy of other ministries in our classis and a hopefulness that the role can be expanded in the future.

Classis advises the BCLDN to provide a thorough funding plan and budget, including ministry share amounts before the agenda deadline for the October 2015 meeting so that each council can have sufficient time to discern the financial proposals.

Rev. David Salverda encouraged churches to have Pastor Vanderleek lead a "Let's Talk About Session" at their churches.

Victoria CRC has had two sessions and highly recommend them.
