- Delegates recited in unison the "Affirmation of Reformed Doctrine and Life"
- First time delegates signed "Covenant of office Bearers"
- Chair thanked Immanuel CRC for hosting and their hospitality.

2. Appointment of Committees for pre-advice to Classis noted by the Chair.

- President appoints pre-advice committees as noted in agenda.

Noted: Overture received from Victoria CCC submitted late as to the R.O.P.

Motion to accept into the agenda the overture from CCC Victoria......MS defeated Overture will be sent back to Victoria CCC who may resubmit for the fall classis meeting.

3. Classical Ministries / Interim Committee

Stated Clerk report: Andy de Ruyter

- highlights agenda items for delegates information
- noted Canadian stated clerks gathering held in January 2017 with Ms. Kathy Smith attending in his absence and Mr. Vic Chen attending as the classis leader.
- Kathy Smith, presented on the Stated Clerks gathering. Interested in feedback concerning:
- (1) Does our new mission statement and our way of doing ministry (seeming to be away from regional focus) reflect the three lenses of classis?
- (2) Is there a tension in our classis between administrative and ministry focus?
- noted the separation of agenda items and ministry reports. All ministry reports for classis are sent in a separate zip file for delegates and are meant to be distributed to all council members and any interested members of each local congregation.
- noted classical credentials forms and the proper procedure for submitting
- church visitor assignments are presented and churches encouraged to complete their visits before March 2018.

Motion to approve the work of the stated clerk......MSC

Classical Ministries / Interim Committee report: Andy de Ruyter

- reviewed expenses from October 2016 classis meeting of \$9194.21
- noted the AGM of the Corporation of Classis BCNW will need to take place at this meeting
- Dr. Steve Timmermans, E.D. of CRCNA will be present at the Wednesday morning session and for a time of Q&A.
- Rev. Cecil Van Niejenhuis will lead a workshop on church visiting during the Tuesday evening session.
- appointed two members of the CMIC to look at the overall mandate of the CMIC and how to better facilitate the work classis gives in relation to administration and ministry oversight.
- appointed a "Going Forward Team" to continue the classis renewal discussion in conjunction with the synodical committee work. Members: Revs. Andrew Beunk, Albert Chu, Trevor Vanderveen, and CMIC members Kathy Smith and Andy de Ruyter. Notes from the team's first meeting are reviewed (addendum report, pgs. 8 &9) Classis can expect some recommendations to be proposed on ministry reporting, ordination examinations and agenda flow at the October Classis meeting.

- -asked for a review committee to be struck for the Ministry to Seafarers. The committee to review future ministry work in light of classis' new mission statement and the retirement of the current chaplain in the Fall of 2017. Also to look at objectives, relevance, staffing, budgets, projections etc. Pg. 15 of the addendum report lists review committee members and mandate. S/C to meet with review committee to detail classis concerns.
- CMIC has initiated a review of how the pre-advice committees do their work for classis meetings and will report to future classis meetings with possible changes.
- in response to classis' request to celebrate the 500th anniversary of the Reformation, CMIC proposes a joint session with Classis BCSE for the Tuesday evening session of the October meeting with a time of fellowship and dinner to be followed by a worship service with a guest speaker. New Westminster CRC will host the event. In order to facilitate this, CMIC requests that the dates for the Fall meeting of classis be moved from October 3rd & 4th, to October 17th & 18th. These new dates will coincide with BCSE meeting dates and make this event possible.

A committee from both classes will be struck to make plans and organize the event.

Motion to move the dates for the Fall 2017 meeting of classis to October 17th & 18th.....MSC

- CMIC has asked The Tapestry to do a presentation at this meeting of their ministry with their church plant in Marpole and merger with Mundy Park and the organization of the 3 campuses and how that all relates to each other.
- noted the review conducted for the Campus ministry at UNBC and have asked the boards chair, Rev. Andrew Aukema to present the review to this classis meeting.
- Classis Regional Disability Advocate, Mrs. Caroline Short, will present on the Mental Health Taskforce and make available workshops for individual councils and pastors.
- the synodical delegates that were elected for Synod 2017 are noted.
- -highlighted survey results of our fall classis meeting, indicating that we will continue to do surveys of each fall meeting. Survey results were also shared with the Going Forward team.
- -reminds churches that they received a template for getting into conformity with BC Society laws that came into effect in November 2016. Churches that have not done so as yet are reminded of the importance of getting this done as not doing it will compromise their charitable status with the government. Contact the stated clerk if you need to receive it again.

Ministerial Items and Actions

- ministerial credentials for Rev. Michael Goheen (retired) transferred to Hope Community in Langley B.C. from New Westminster CRC and for Rev. John Koster (retired) from Agassiz CRC to Maple Ridge CRC. Presented for information as retired ministers credentials can be transferred directly between churches without classis approval.
- regional pastors report that mentors have been assigned for Revs. Jesse Pals and Charles Van Hoffen who sustained their ordination examinations at the last classis meeting.
- proposal from Vancouver 1st CRC for a commissioned pastor position will be dealt with at this classis meeting.
- noted reports from oversight committees for the art 17 from Duncan CRC will be heard under executive session.
- 2017 ministry shares, both classical and denominational presented for information.

From Addendum report:

- permission asked to destroy submitted classical credentials from 2009 to 2015, as all matters presented in credentials are part of official classis minutes.

Motion to shred the Classis credentials from 2009 to 2015......MSC

- noted with thanks and appreciation that this will be the last classis session Rev. Chelsey Harmon will serve as recording secretary. Ms. Kathy Smith, secretary of the CMIC will take over this position for the next classis meeting.
- Seafarers Committee asks classis to deal with the following matter:

That in light of the current Chaplains forthcoming retirement and the co-ownership of the Manse, the house be sold with the proceeds being divided between the chaplain and classis according to the ownership agreement and that the monies for classis be retained for future housing needs for a new chaplain.

- Rev. Ken Vander Horst, on behalf of a committee appointed by the CMIC, presented a working draft of revisions to the Classis Rules of Procedure. Following several comments that were received from the floor, the committee will continue its work on revisions and present again to the Fall meeting.
- reminder that ministry reports from the denomination are meant to be forwarded to all church members, via email, bulletin, webpage etc. These reports are meant for all members to enjoy and be informed of what is happening within our denomination.

- Rev. Trevor Vanderveen presented to Classis and took questions about the position, the working relationship between the committee and the church, and the grounds for the request.

- Stated Clerk reports that the Synodical deputies, Rev's Rich DeRuiter from Pacific North-West, Rev. Tom Oosterhuis from Alberta North and Rev. Rudy Ouwehand from BCSE have conveyed that they will concur with an approval from classis for this position. Classis entered into a time of prayer for this ministry.

Pastor Hyung-Jun Kim presented to Classis about what is happening through the Mosaic House. Pastor Kim's position has expanded at New West CRC to a full-time position connecting the international student community and the church through discipleship, etc.

Classis prayed for the continued blessing of this ministry.

- Classis entered executive session to hear reports from the oversight committees for the art17 with the Duncan CRC and former pastor, a pastoral question from one of the local churches and to hear a report from a pastoral support team.

7. Denominational Ministries

World Renew: Dave Mayer

Mr. Mayer thanked the churches for their support and asked for feedback about how World Renew is doing. This feedback can be provided in person to him or through the World Renew website (worldrenew.net)

World Renew is at the disposal of individual churches to help them discover the unique calling out of the myriad of needs in the world.

Youth Champion: Ashley Patton

Ms. Patton presented to classis about her role as Youth Champion. In this role she regularly checks with churches for support, development etc. Ms. Patton invites churches to receive her support and directed churches to available resources and appropriate denominational websites.

New Missions Agency: Jenny deGroot

Ms. deGroot presented to Classis as the two agencies enter the final stretch of the amalgamation, including sharing the decision for the New Mission Agency director, Rev. Zachary King and the challenges of branding the New Mission Agency.

Rev. Michelle Ellis led a devotional and closed our afternoon session in prayer.

Report of The Tapestry

Rev. Albert Chu presented to Classis about what's happening with ministry at The Tapestry (Marpole, Mundy Park, Richmond campuses) giving a history and a present day report on how the three churches are one, yet separate in their communities, each one focusing on local outreach and missions. He explained how the three form an elder board together and their responsibilities to each other. The Tapestry uses a collegiate style model, one elder board made up of elders from each campus, overseeing the leadership and staff at each site.

Rev. Chu laments the fact his position has become more administrative than pastoral, but marvels at Gods work in expanding the Kingdoms work in these three communities.

Rev. Chu also presented an update on Engage Vancouver (an initiative through Home Missions) and informed us that the next Missional Café will be on April 1 at First Vancouver Church Rev. Jesse Pals also shared about the church plant he pastors in Marpole.
