Stated Clerk Report

March 3rd & 4th, 2015

1] Welcome to Session 68 of Classis British Columbia North - West.

A big thank you to the council and members of the Immanuel CRC for their hospitality in hosting this meeting of classis.

2] The agenda for this meeting will keep us busy with 2 commissioned pastor job description approvals, a list of ministry presenters, reports on LDN renewal, CDT thoughts on to proceed, report on the overture concerning making a joint executive for SCT with BCSE, the corporation meeting, classis renewal team report, some guest speakers and as well all the regular classis committees reporting.

NOTE: Classis BC South East & Classis BC North West will be meeting in joint session on the Tuesday session from 4:00 – 9:00 pm at the Ladner CRC for a time of worship and prayer. (delegates will be bussed to and from) After dinner Rev. Darren Roorda, Canadian Ministries Director, will be speaking to/with delegates, followed by *The Synodical Committee to Provide Pastoral Guidance regarding Same-Sex Marriage* who will be hosting a consultation session in preparation for their report to Synod 2015

- 3] As stated clerk I have engaged in numerous emails, telephone calls, conference calls, correspondence, reports, meetings, dealing with requests and information from pastors and councils, continual updating functionaries lists, web site updates and organization, organizing marriage registrations for new pastors in our classis as well as some temporary registration numbers for visiting pastors, set the examinations in place and assigned the various teams needed for these examinations, organized CMC agenda material and lead meeting, recorded executive minutes, set agendas, recorded and distributed classis minutes and regular administrative duties on behalf of classis. Other work done included spending time on forwarding announcement emails, denominational and government communications, etc. to churches, committees, and others as required.
- **4**] On January 20th and 21^{st,} 2015, I attended the first ever Canadian Stated Clerks Conference at the CRC offices in Burlington Ontario, along with David Salverda representing the CMC. Each Canadian classes was invited to send the stated clerk and one other classes leader to this conference for a time of sharing, fellowship and study, looking at items such as the current state of "classis" in Canada, working better together, desired future for classis, denominational resources, being served by ministries, Canadian CRCNA National Gathering of 2016

and methods on connecting with churches etc.

Conference leaders and presenters included Darren Roorda, Lis Van Harten, Karl Westerhof, David Koll and Mark VanderVennen.

There was a \$400.00 cost per classis that was approved by the CMC. The rest of the conference costs (travel, lodging, meals etc.) were covered by the Canadian office of the CRCNA.

CLASSICAL MINISTRIES COMMITEE REPORT TO CLASSIS BCNW March 3rd & 4th, 2015

The classical Ministries committee does most of its work by email conversations, phone calls and conference call meetings. A conference call meeting was held on January 29th where several key issues were discussed and items planned for the agenda of this classis meeting.

1] CMC Actions

Reviewed and approved expenses from Classis meeting in October 2014 - \$5275.19

Appointed Rev Harvey Roosma to serve as chair of classis and Rev. Jo Schouten as Vice-chair.

Rev. Chelsey Harmon will graciously serve as recording secretary again.

Rev. Walt Vanderwerf will lead worship on the opening session and the Wednesday morning session and be part of the prayer / worship team at the joint-session.

Approved final arrangements for the joint session of classis with BCSE.

Bus to transport delegates at 3:30 to Ladner CRC

Joint session to begin at 4:00 pm with opening remarks and then a time of prayer and worship.

Following dinner and time to fellowship, there will be a short time to celebrate and thank Martin Contant at his retirement, then Canadian Director Darren Roorda will address the delegates and following will be the listening session by the denominational committee on providing pastoral guidance for same-sex relationships.

Stated Clerk and Classis Leaders Conference Jan. 21/22, 2015

David Salverda and s/c Andy de Ruyter attended this conference in Burlington on January 20/21, 2015. Considerable time was spent discussing relevant issues facing our churches and how the Canadian office can partner with Classis in its work supporting the local churches. A document / notes on the discussions, thoughts and items discussed will be made available. S/C will distribute this to the CMC once it is received and also to the

churches and at the classis meeting to the delegates. (report in the CRC News on January 28th)

Received letter from Immanuel CRC on lifting suspension for Rev. Peter Lim. S/C to report to classis that proper procedures (CO) were followed and full reconciliation has been achieved between Pastor Lim and the Immanuel CRC council. Pastor Lim has now been granted full retirement status.

AGM for the Corporation of Classis BCNW (agenda and minutes of AGM in agenda package, pg's) Will be using shorten form so shouldn't take more than 10 minutes. Needed are motions approving budget, auditor and directors for corporation minutes. (will be done following the classis treasurers report)

Ministry funding tax report

Classis Treasurer David Pel has been doing a review of accountability criteria for the ministries classis financially support. Items such as appointing directors, control over spending, agreement outlining accomplishments on behalf of classis etc.

He will make a full report to classis on what needs to be done by each ministry. Warns CMC that some ministries may not like the changes but classis needs to be in line with government regulations.

<u>Classis Review Team</u> (Martin Vellekoop, Jo Schouten, David Salverda)

- will be making brief report to classis on discussions and what may be coming in future reports and recommendations.

Overtures

Classis acceded to an overture from Maple Ridge CRC on looking at having a joint executive with BCSE for the Safe Church team. Chelsey Harmon, our classis Rep and the S/C will be making a report to classis that we move forward with this proposal and make a full recommendation with motions at the October classis meeting. (Recommendation will be in the addendum report shortly before classis meets)

Faye Martin will be reporting to Classis on this as well and on the current needs assessment process currently underway with our churches.

<u>LDN</u> (two documents in agenda package pg's)

Committee will be presenting to classis an expansion of their mandate with additional staffing / funding requests. S/C's of BCSE and BCNW met with LDN board on February 5th to discuss procedure and implications of what they are proposing.

Collaboration Opportunity for Ministry to International Students and Scholars

(- two documents in agenda package, pg's)

New West CRC will present and request support and partial funding for this new ministry.

Temporary Marriage Registration Number

Request from Rev. Jan Wieringa, a retired minister from the Gereformeerde Kerk in Holland, for a marriage registration # so he can officiate at this granddaughters wedding on May 2, 2015.

Rev. Wieringa was a CRC minister in the 60/70's before he returned to Holland where he still lives.

Request was approved by CMC and S/C issued documents.

Richmond CRC AGM

Members of the CMC will attend the AGM of the Richmond CRC on March 3rd, 2015 in its role of supervision in the sale of the building and lands to The Tapestry.

21 Ministerial Concerns and actions

Commissioned Pastor Job Descriptions

Duncan CRC has submitted a request to approve a commissioned pastor job description.

(Copy of job description is at the end of this report, pg.)

S/C has submitted the job description to synodical deputies for their possible concurrence with a classis decision. S/C will inform classis of the Syn. Dep. decision after they make their decision.

note: Duncan CRC will call Henry Vanderschaaf to fill the position if approved. An examination will be scheduled for the October classis meeting.

Maple Ridge CRC has also submitted a commissioned pastor job description for classis approval.

(Copy of job description is at the end of this report, pg.)

S/C has submitted the job description to synodical deputies for their possible concurrence with a classis decision. S/C to inform classis of the Syn. Dep. decision after they make their decision.

If approved, Maple Ridge CRC will call Shane Rozeveld to fill the position. Classis will need to decide if Shane needs to be re-examined as this job description is similar to the one he filled in his years at Alberni Valley CRC. (church order 23 say his (re)ordination requires the approval of classis and that his former church presents good ecclesiastical testimonies of doctrine and life to his new church and classis.)

CMC proposes to classis that Shane not be re-examined and Maple Ridge CRC be given permission to ordain Shane to the new position.

Classis BCNW Agenda March 3rd & 4th, 2015

Note:

CMC advises church councils that are considering a commissioned pastor position for their churches to carefully look at church order art 23 and it complexities in the process. There is a lot of confusion and misunderstanding out there on procedure.

Re-ordination request for Daniel Devadatta

CMC received request from Daniel Devadatta for re-ordination. He was honourably released in 2002 by our classis (New West CRC) to take up a new ministry in Pakistan and has returned to the States.

From Classis BCNW Minutes, March 2002

12.1 **Motion:** Classis British Columbia North-West declares that **Rev. Daniel Devadatta is honourably released** from the office of Ministry of the Word in the CRCNA in accordance with C.O. art. 14.B.

Daniel now lives in Grand Rapids and is doing pastoral care work with the Hope Network, an outreach ministry sponsored by LaGrave CRC in Grand Rapids. This work requires an ordained minister, hence the request for Daniel to be re-ordained into the minister of our denomination.

Church order says that we (Classis BCNW) need to interview and examine him, and declare him eligible for a call under co 14e, as we were the ones who released him.

Because he now lives in GR and his new ministry will be in GR, S/C is trying to convince everyone (deputies, candidacy committee, CMLT, Classis Grand Rapids South and their deputies) that it would be a good idea for Classis Grand Rapids South to do the interview/examination saving expense and time for both Daniel and our classis. Reasons? This is the classis he is a member of, this is the classis that would approve his new position from the LaGrave CRC and this is the classis / church that would hold his credentials. (initial conversations with synodical deputies, candidacy committee and classis GR South seem to be favourable)

S/C will inform classis of the outcome of the discussions. If it is determined that we still need to do the interview it will be scheduled either for the upcoming March meeting or the October meeting of classis.

Rev. Vinh Le Release

Pastor Vinh has informed classis that he has sustained his examination for ordination into the Presbyterian Church of America and has accepted a call to be a missionary to the Vietnamese people in Everett Washington. Upon receipt of his ministerial credentials from the New Westminster CRC, and concurrence from the synodical deputies, the CMC will move that classis declare Rev. Vinh Lee honourably released from the office of Ministry of the Word in the CRCNA in accordance with C.O. art. 14.B.

3] CDT Report (Classis Development Team)

CMC continues to be "challenged" in developing a plan and proposal for classis on the future of the CDT. In a recent discussion the following thoughts and concerns were brought forward.

- change mandate from a team that looks at church plants to a classis person / coach that would assist churches with looking at their own unique situations and how to build in their own communities with the resources they have.
- are there persons available who have a heart for this type of ministry that can help classis understand what its role should be in the future
- unless a clear mandate is accepted and understood, can we really continue with this?
- the need for discussion and input from the churches is needed
- how do we oversee current ministries and what are the responsibilities in regards to accountability to classis in funding and ministry oversight?

CMC is proposing to classis that it continue to try and define what the CDT will look like in future and find people to help shape that direction. CMC asks for classis patience in receiving a proposal and that the member churches / pastors forward any recommendations, ideas, available persons who have a heart for this type of ministry that can help shape classis role in church development to the CMC.

Job Description

Leader of Congregational Life

Position Summary

The Leader of Congregational Life serves the Church by encouraging and enabling member participation in the life of the congregation, and by providing pastoral care, preaching, and leadership in youth/young adult ministry. Participation in Council, Elders, and administrative meetings is expected.

Responsibilities

- 1. Directly encourage members to become active participants within our congregation in areas such as worship services, joining small groups and Bible studies, and attending social events.
- 2. Equip and model for the congregation ways to reach those outside the faith.
- 3. Welcome newcomers and help to enfold them in the congregation by inviting them to participate in the life of the Church.
- 4. Prepare sermons for an average of 9 worship services per year.

- (b) Facilitate connecting the older and the younger generations.

- 7. Serve as a Council representative on the Outreach Committee.
- 8. Attend meetings of General Council, elders, and administration.
- 9. Take a lead in the ministering to the congregation's youth (ages 12-18) and single young adults (ages 19-30) through activities such as:

Cooperating with others in the community to set up regular "Youth/young adult" worship events Organizing "Close Encounters" weekends

Work with leaders of "Total Impact" to organize activities.

- 10. Attend conferences or seminars when appropriate.
- 11. Other duties as assigned.

Accountability

This position is supervised by the Senior Pastor on a regular basis and is accountable to the Church Council with respect to responsibilities, terms and conditions, and evaluation.

Monthly written reports of activities shall be provided to the Senior Pastor and to the elders.

Youth Pastor Job Description Maple Ridge CRC March 2014

I. Youth Ministry Purpose

To develop a Youth Ministry in which students are introduced to Jesus and discipled toward spiritual maturity. To provide an environment in which prayer, worship, and the study of Scripture are central and exercised in a way that is relevant to the youth of today, taking into consideration their current spiritual state, specific youth culture, family background, and developmental stage. These spiritual disciplines are seen as essential for lasting spiritual growth.

To build a strong community of youth that provides safety, fun, unconditional acceptance and care. This fellowship is designed to bring holistic care to young people in an environment that facilitates commitment, not only to one another, but to God through Jesus Christ.

II. Responsibilities

General Responsibilities

1. Oversee the spiritual development of the youth of Maple Ridge CRC.

- 2. Recruit, train, and oversee a group of youth and adult leaders.
- 3. Create opportunities for youth to minister and serve.
- 4. Project and submit for approval a Youth Ministry plan and budget to the Operations Board for inclusion in their annual budget, managing the budget throughout the year.
- 5. Mobilize other leaders/resources to equip families

Specific Responsibilities

- 1. Overseeing the spiritual development of the youth of Maple Ridge CRC specifically involves: a. Planning and leading regular youth meetings (once per week) with volunteer teams in age-appropriate groupings.
- b. Spending one-on-one and group time with youth to build relationships and stay connected with current youth culture, as time permits and as needed
- c. Creating and implementing a vision and strategy for MRCRC youth ministry with volunteer leadership team
- d. Work alongside other ministry leaders in reaching out to the youth of the community, providing opportunities for non-churched youth to connect with the MRCRC youth program.
- e. Meeting once a year with the parents of youth and being a support and resource to them. Communicating information effectively to youth, parents, and the MRCRC congregation.

2. Recruiting, training, and overseeing a group of youth and adult leaders specifically involves:

- a. Holding regular youth leadership meetings.
- b. Developing the leadership abilities of both student and adult volunteers.
- c. Being a resource and support to volunteers, helping them fulfill their tasks.

Policy.

3. Creating opportunities for youth to serve specifically involves:

- a. With other ministry leaders, facilitating opportunities for youth to minister within Maple Ridge CRC according to their gifts and talents.
- b. Providing opportunities for youth to engage in service projects and/or missions trips either locally or abroad.
- 4. Project and submit for approval a youth ministry plan and budget to the Operations Board for inclusion in their annual budget, and manage the budget throughout the year.
- 5. Mobilize leaders and/or other resources to equip families in ministering to their teenagers.

III. Relationships

Senior Pastor - The Youth Pastor is directly accountable to the Senior Pastor in all matters relating to the performance of his/her work and will meet regularly.

Church Council - The Youth Pastor will serve as an advisor to the church Council in matters relating to youth; he/she will be an auditing and resource person to Council.

Other Staff Members - The Youth Pastor will cooperate and work as a team with other staff. There will be weekly team meetings with Senior Pastor and other ministry staff.

IV. Evaluation

The performance of the Youth Pastor will be evaluated on an ongoing basis by the Operations Board.

Classical Listening Sessions

When the 2013 CRC Synod appointed the committee to provide pastoral guidance on same-sex marriage, it encouraged the committee to follow a "shepherding model" in preparing its recommendations. These listening sessions are one way in which the committee is implementing a shepherding model in its work.

What is a shepherding model? Rather than have the committee immerse itself exclusively in academic reports or biblical and theological research before offering its advice to the church, a shepherding model encourages the committee to engage the church, its leaders, and its members in conversation as it explores the issues that comprise its study. This better ensures that the committee's work is connected to what is happening in actual ministry and it brings the wider church into the conversation earlier in the process.

What will happen at the listening session? Well, listening. Representatives of the synodical committee will make a brief presentation providing background on the legal and cultural aspects of same-sex marriage in Canada and the United States. They will then introduce a set of three questions for discussion, first in small groups and then with the entire assembly of delegates. The entire process will take approximately 90 minutes

Who will be listening to whom? The synodical committee representatives will be listening to the conversation among classical delegates. The classical delegates will be listening to each other. And in it all, we'll be listening to where the Spirit may be opening avenues for ministry and leading the church in challenging times.

These listening sessions are intended primarily for delegates to classis from the various church of classis. Visitors to classis on the day of classis are welcome to participate (i.e., this isn't an executive session sort of things). We would prefer, however, not to give general invitations to church members interested in the topic to participate. This is to keep the discussion group size in the 25-50 person range, which is optimal for this sort of session.

LDN Standing Committee Spring 2015 Report To Classis BCSE and BCNW

In the spring of 2014 Victoria CRC sent a motion to classis,

"to expand Pastor Vanderleek's job description as LDN facilitator to include a mandate to provide annual seminars to councils throughout the province. With more than 25 churches in BCNW and BCSE it is our suggestion that a 34 time or possibly even full time position is warranted."

After some discussion and the realization that more information was needed, the motion was withdrawn. A second motion was brought to the floor,

"that classis recognizes the important value of elder and deacon training and the important role that Pastor Wilma Vanderleek plays, and instructs CMC to work with LDN and Victoria CRC to come with a concrete proposal at the Fall 2014 Classis meeting."

Since that time the LDN Standing Committee has been at work to come up with a concrete proposal for both classis'. The deadline of Fall 2014 Classis was not attainable, but the committee did meet with the chairs of CMC in September 2014 and agreed with their recommendation to wait until the Spring 2015 classis to make the proposal.

The work that the Standing Committee has been involved with can be compared to a home renovation. When you consider a renovation it is important that you look at your foundation and determine whether it is solid enough to warrant a reno. If the foundation isn't solid, you may as well tear down the house and begin from scratch, but if it is solid, it may need some minor reinforcements but a reno is possible.

We have looked at our foundation, our vision and mission statements and our mandate, and we have determined that they are solid - they needed some adjustments but our foundation is firm.

We also have been looking at the structure, and realize that some things may need to change, and we need to do an addition (Let's Talk About workshops). We also realize that we need to hear from others (pastors, council members, alumni and mentors) to ensure that the structures we put in place will serve our denomination for years to come.

The LDN Standing Committee will be making a proposal to the Spring Classis. We will be asking for increased funding, to hire an administrator and to add 5 "Let's Talk About" workshops free of charge to the churches, per year (one in the north, one in the interior, one on the island and two in the lower mainland).

We agree with Synod 2013 that "life long leadership development is a priority for renewal in our denomination and essential for the flourishing of the church." We believe that LDN is already strategically placed to offer such leadership development to the churches of both classis'.

While the work of planning the "reno" took much energy over this past year, the 3 year LDN program continues. Currently we have 18 participants, 5 from Classis BCNW and 13 from Classis BCSE, who meet one Saturday per month. They are in year 2 of the LDN Curriculum, which is New Testament focussed, learning new ministry skills, journaling and meeting in small groups. We are excited to see how God is using LDN to shape leaders who desire to serve him in their local churches, neighbourhoods and workplaces.

BC LDN Draft Funding Proposals for Classis BCNW & BCSE

The BCLDN standing committee will be making a proposal to the spring classis meeting, which will make leadership training in the churches more accessible. Our proposal will offer to the churches five *Let's Talk About* workshops per year that will be free for the attendees (one in northern BC, one in the interior, one on the island and two in the lower mainland). In the past, our facilitator has offered these workshops and has had to charge per person for attendance to recoup the costs incurred. At the 2014 spring session of Classis BCNW, Victoria CRC made an overture to classis asking that the facilitator be given a full time position so that the sessions could be more accessible to all leaders. This overture was supported in concept, but was returned to Victoria CRC seeking more information. The BCLDN committee has worked diligently for the past year to develop this proposal.

The BCLDN committee agrees with Synod 2013 "life long leadership development is a priority for renewal in our denomination and essential for the flourishing of the church." We believe that LDN is already strategically placed to offer such leadership development to the churches of both classes and in fact has been already doing so over the past few years. This proposal will ensure that all of the churches in our classis can have easy access to this training, regardless of distance or financial situation.

<u>MOTION</u>: That classis approves the following revised Vision & Mission Statement and Mandate and that they be added to the BC LDN Standing Committee Mandate in the <u>Rules of Procedure</u>.

- discover CRC leaders who desire to be equipped for ministry
- develop biblically grounded leaders

- promoting leadership training within the BC CRC churches
- providing a three year curriculum that integrates Biblical content, ministry skill competence and character development

Re: Collaboration Opportunity or Ministry to International Students and Scholars

Dear Classis BCNW, CRHM CRWM

Since our congregation welcomed our first four visiting scholars from China in the fall of 2010 we have experienced a wonderful blessing of the Lord on a ministry to international students and scholars from a variety of different countries that continues to bear much fruit. A significant number of people in our congregation, young and older, have been blessed through this ministry by way of lunch fellowships, one-to-one discipling, Chinese New Year senior's luncheon, MOSAIC Home, friendship partners, and numerous adult baptisms, just to name a few. With the writer of Psalm 118 we have repeatedly stated, "the Lord has done this, and it is marvelous in our eyes." (Psalm 118:23)

Our leadership team would like to strengthen the capacity of our MOSAIC ministry and begin to develop a chaplaincy-type presence on some local campuses in the area of our church (SFU-Burnaby, SFU-Surrey, and/or Douglas College-New West). Moreover, we envision this New West CRC part-time staff position building relationships with area CRCs to encourage and collaborate with them in developing and strengthening local ministries to international students and scholars.

The position that is being proposed is: *Coordinator of MOSAIC and Campus Connections*. We are hoping this position will be the result of a collaborative effort between New West CRC, Classis BCNW and the two agencies, CRWM and CRHM. We are approaching Classis because we see this as an outreach opportunity to internationals on our local campuses and want to encourage congregations in Classis to engage in this ministry. We have approached CRHM because we believe this position creatively addresses the need for a chaplain-type presence on campuses with a specific focus to minister to the many unreached people that the Lord is bringing to our neighborhood campuses. And we have approached CRWM because we wish to collaborate with in-field missionaries to facilitate ongoing discipleship and connection with pastors and congregations for students and scholars when they return to their home countries (i.e. many of our internationals are from mainland China and we have already begun to develop contact with CRWM teacher, Wayne TenHarmsel in Beijing).

We wish to pursue this initiative in small steps and hope to create a half-time position with an annual salary of \$25,000. We have already had initial conversations with representatives of CRHM and CRWM about forming such a position and have received initial agreement in financially supporting it the way we suggest below.

We are prayerfully anticipating that this position could be financially resourced through a three-way partnership for a period of three years. Following the initial 3-year period we will reconsider the financing in discussion with all involved partners.

The proposed financing arrangement is as follows (per annum):

New West CRC - \$12,500 Classis BCNW - \$7,500

CRHM & CRWM \$5,000 (\$2,500 each)

Total \$25,000

We hereby share this proposal with you, humbly requesting your financial partnership and collaborative conversation, and look forward to any further questions or conversations you may wish to have on this exciting ministry opportunity.

Dear Classis,

I think it is important for you to know the work that I am doing within the Canadian church of the CRCNA. I am new to this work after serving churches in both the USA and Canada and as such I am firm in my belief that I am called to serve you as local leaders and parishioners.

I have now been serving as Canadian Ministries Director for a mere 6 months and feel blessed to serve in this capacity. My posture continues to be one of learning to understand and in this I continue to have Ben Vandezande's voice ring in my ears: "Give yourself 18 months before the learning curve begins to even out." I have had numerous conversations with agency leaders for the sole purpose of learning about their work and am working my way through all the Canadian denominational staff to know them well.

But learning does not mean that action is not demanded. My passion for the local church drives me to work together with others in pursuit of benefits for both classis and local church in ways that will bring us as agencies and denominational entities from acting less independently and more co-operatively amongst each other while in service to the local church.

Some of the examples of work in the Canadian context that demand my time:

Being present with local churches and pastors on an ongoing basis

Fostering collaboration among agencies on unique projects:

Mission Montreal (Urban Ministry Partnership in Montreal)

Safe Church Team: Classis BCNW - Jan 2015

At time of writing, the Safe Church Team is at a crossroads in its ministry. Understanding that functioning as a safe church is an intentional and ongoing process, a presentation was made at the fall classis meeting, informing delegates that the Classis Safe Church Teams (SCT) of BCSE & BCNW will conduct a **Ministry Needs Assessment** with each individual church.

A key person in the implementation of the work of the SCT is our **Abuse Prevention and Response Coordinator** (**APRC**). Faye Martin has been appointed by both BCSE & BCNW to serve as the APRC for the interim. We regard this an opportune time to explore ways in which we can be more effective as a ministry.

THE PURPOSE OF THE MINISTRY NEEDS ASSESMENT (MNA)

The purpose of the MNA is to explore ways in which the Safe Church Team can **best serve the needs** of the churches. To achieve this, it is essential that we have input from the leaders of each ministry, including church councils, to help determine how the Classis SCT can effectively educate, support and work with their ministry leaders.

The SCT will need a broad range of responses that help provide a picture of the needs of each individual church. Each church's participation in the MNA will help guide the work of the SCT & the new APRC in the coming years as they support the important work the churches are doing.

METHOD

SCT representatives will be delegated to meet with <u>each church</u>, they will work through a specific set of questions, and the SCT executive will compile the responses. In this way a general picture of the SCT work as well as particular details pertaining to each congregation will emerge.

PARTICIPATION:

The intent is to bring together for 90 minute meeting:

- 1. Church Staff
- 2. Church Councils
- 3. **All leaders** of ministries that involve children, youth, young adults & vulnerable persons such as those with disabilities. This would include nursery team leaders, volunteers in Sunday school, Gems, Cadets, youth ministries, leaders that accompany mission trips, young adults, Friendship ministries etc...

Each individual leader will participate as we walk through the questions. The importance of participation of all the leaders involved in these ministries cannot be stressed enough. Through their responses a picture will emerge that will help indicate where the needs lie in terms of being a safe church.

"It takes a whole church to be a safe church"

BENEFITS: Why come together to focus on the church being a safe place?

- 1. Provides a great opportunity for further discussion of this important subject that is foundational to important work done in the church and ongoing faith formation.
- 2. Promotes a message of unity on the subject and working at this together.
- 3. Provides an opportunity for volunteers to give their input.
- 4. Participation and presence of council members gives a strong message of support to the ministry leaders/staff/volunteers. Church councils are responsible for all that takes place within the programs connected to their church. Their role is paramount as responders and decision makers regarding any abuse related incident.
- 5. As overseers of ministries, the role of church staff is integral to the ongoing process of being a safe church.
- 6. Provides the church with a overview of their safe church related needs and how the SCT and the Abuse Prevention and Response Coordinator can **support** the important work being done in the church's ministries.

STRUCTURE

The CRC mandate adopted by classis for the Safe Church Team is:

- 1. Education: provide educational opportunities for churches regarding issues surrounding abuse.
- 2. Support: help churches provide compassionate support for those who struggle with abuse.
- **3.** Advisory Panel Process: offer a fact finding & listening panel in cases of allegations of abuse against a church leader.

The focus is on the SCT mandate through a series of specific questions clustered around the top

8 GOALS FOR SAFE CHURCHES derived from the 3 fold mandate. These **8 goals** are:

- 1. That every church has a council appointed representative on the Classis Safe Church Team.
- 2. That every church has a Safe Ministry Practices team at the local level.
- 3. That every church has written and implemented their own Safe Church Policy.
- 4. That every church regularly accesses training for their staff, leaders and volunteers.
- 5. That every church leader is actively committed to safe church practices within their area of ministry.
- 6. That every church uses a Safe Church curriculum specifically designed to train, guide, and empower children & youth with regard to their personal safety.

- 7. That every church has become a place in which everyone feels that she/he can raise issues of abuse without fear or shame
- 8. That every church council has knowledge of, and follows approved protocols for, responding to allegations of church leader misconduct.

Goals 1-6 are derived from the **Education** mandate, goal seven from the **Support** mandate and goal eight from the **Advisory Panel** mandate

MNA DATE & TIME

The SCT requests that **each church choose a date and time** for the **MNA** to take place. SCT representatives will accommodate that timetable and be present to facilitate the process.

BCNW OVERTURE: BCNW CMC has initiated dialogue with BCSE SCT executive. This is follows the decision made at their fall classis meeting that passed an overture brought by the council of the Maple Ridge CRC requesting a study of the feasibility of establishing a joint BCSE/BCNW Safe Church Team Executive and report back to the Spring 2015 meeting of Classis.

GENERAL SCT/APRC WORK:

- 1. John Stellingwerff & Faye Martin were present at LDN on Jan 10, to provide some training and dialogue with the participants. Safe Church training is a mandatory part of the LDN program. SCT appreciates this opportunity to interact with the participants and support the important work they are doing in their churches.
- 2. Church leaders regularly make contact with the SCT for input and assistance as they walk through what is sometimes unknown territory fraught with many questions. Responding to situations that arise within the churches continues to increase. These types of responses include multiple cases involving domestic violence, historical sexual abuse, and more current situations involving behaviours that cross the appropriate boundaries and affect the safety of the church.

INTERIM APRC WORK & SHORT TERM PRIORITY GOALS

In November a letter was sent from myself to all the SCT and contact persons in BCNW on a list provided to me by John Stellingwerff. The letter was an update on the work of the SCT in the classis. Each person was informed of;

- 1. my appointment by both classes as the Interim APRC and the resignation of John Stellingwerff,
- 2. the action of the fall classis to form a committee to look at the **feasibility of forming a joint SCT executive** with the 2 classis.
- 3. the Ministry Needs Assessment that will be conducted with the churches.

It is my intent to make **personal contact** with all these persons and **partner with them** in the facilitation of the MNA. This will include travel to the Northern Region to work with the churches in the executing of the MNA. Henry Jonker has agreed to facilitate the Van Island Churches with the local reps and committees. I will work with the Lower Mainland churches.

A key focus will be to begin to **rebuild the Classis SCT** in each geographical area. This will include contact with church councils to encourage them to appoint a representative to serve on the classis team.

This past year, significant work has been done in BCSE to update the **Terms of Reference** for the classis SCT. This document outlines how the SCT is structured and functions. With the appropriate revisions this could also become a working document for the BCNW classis regional Safe Church Teams. This would be introduced as a matter for consideration to the respective regional teams. If adopted, a copy will also be on file with the CMC.

I will provide the **BCNW CMC with regular reports** of the work I do in this classis and progress made in facilitating the MNA. I greatly value the interaction, dialogue and encouragement I receive from this group.

FAREWELL: to John Stellingwerff

On Nov 29, the BCSE SCT, along with their spouses held a farewell dinner for John (& Doreen). Following dinner the team gathered in the living room and each member had an opportunity to thank John and share how his work had been a blessing. An appreciation gift (monetary) was given. We are grateful for the 7 years he contributed to the Safe Church Team. We truly wish the best and God's grace to John & Doreen & family.

The BCSE and BCNW joint CMLT committee continues to meet on a regular basis. Our main objective is to serve, guide and support students and pastors towards candidacy for minister of the word and sacraments in the Christian Reformed Church. The CMLT functions as an umbrella which includes the Student Fund Committee.

The main routes that people can follow towards candidacy are:

- 1) In resident MDIV Calvin Theological Seminary (CTS) student; (Art. 6)
- 2) Non-resident MDIV CTS student; (Art 6)
- 3) EPMC (MDIV non-CTS) either 10 week resident or 24 month nonresident. (Art. 6)
- 4) Ordained Pastors from another denomination who wants to be a candidate in the CRC.(Art. 8)

The CMLT also provides support to those seeking ordination via Art. 7 (individuals with exceptional giftedness) and Art. 23 (Commissioned Pastor). We work with individuals and students from a wide range of backgrounds. Some simply want more information. Others are well on their way to candidacy.

We have worked closely with Regent College for several years and host a luncheon every January for students who are pursuing or interested in ministry in the Christian Reformed Church. We are also continuing to establish a relationship with ACTS Seminary in Langley. This past fall we hosted an information luncheon on the campus of ACTS seminary.

We ask Classis to Pray:

- 1) That God would equip, develop and affirm His call on these new emerging leaders in the CRC.
- 2) That God would equip the CMLT in its role of providing support and encouragement to a wide range of individuals considering or seeking ordination in the CRC.
- 3) That God would provide the financial resources necessary (through the Classis Student Fund) to support students seeking assistance for the 2014-2015 academic year.

downtown friends Classis BC-NW March 2015 Update

In order to respect people who are exploring the Jesus-Way, **please do not post this update on a website.** This is meant to be shared aloud or hung on church bulletin boards, so as to protect the details of people's lives and keep them anonymous. Thank you!

In 2014, we asked you to pray with us for the **potluck-and-Jesus-conversation groups** which were soon to begin. For a couple of months, each Sunday a different small group of unbelievers and believers shared a meal followed by reading & discussion of a section of Luke's gospel. Unbelievers invited included *downtown friends* members' neighbours, friends from service organizations, an entrepreneurs club, and an art studio for the working poor, a housemate, a graduate school classmate, and long-time friends. Although none of those who participated has yet made a decision to follow Jesus, almost all of them are **in ongoing spiritual conversation with** *downtown friends* at our events and in more intimate settings.

*Eva, a hard-working but very poor artist who is scared of Jesus but is drawn to believers recently made this comment about 4 believers she'd interacted with during our dinners or parties. "You all have light around you; I can see that. I'm drawn to that but I'm just not ready." We invite you to pray with us that those like Eva will each be "translated from the kingdom of darkness into the kingdom of the Son, to receive redemption, the forgiveness of sins (Col 1)."

Some of our friends in the Jesus-conversations were affluent and others poor, and we represented many ethnic backgrounds and nations. **The all-nation & all-class makeup of the groups modeled God's Kingdom reconciliation.** In fact, on Thanksgiving, an Aboriginal Australian with a White spouse commented on how much he liked the diversity of the dinner. Since his workplace and social settings are all multiethnic, we knew he was remarking on the socioeconomic character of the gathering..

This heterogeneity of our church and ministry, although beautiful and Christ-like in its inclusiveness, is also a hard teacher. As brothers and sisters, we work to support each other through substance addiction, physical disability, mental illness, poverty, alcoholism, and finding work after serving time in jail or prison. And we help each other to repent of pride, self-reliance, and selfishness. The rich learn from the faith of the poor, who depend on God to "give us our daily bread," and who expect and see daily miracles. The poor learn to accept God's grace by receiving employment or material help from the rich.

As *downtown friends* has grown, we've come to include people in 5 different downtown neighborhoods. This fall we committed to a 9-month journey to explore the possibility of living in intentional community in one place. This journey has included a weekly meeting for **discerning prayer**. We've also spent time together learning and practicing **healing prayer and prophesy in order to hear God speak and see God act more clearly and powerfully** among us and through us to unbelievers around us.

Sisters and brothers of Classis, with you we rejoice that God promises "My grace is sufficient for you, for power is made perfect in weakness." And with Paul we "will boast all the more gladly in our weaknesses that Christ's power may rest on us." 1 Cor 12:9

Dear Colleagues and Delegates of Classis BCNW:

This may be my briefest report ever submitted to Classis ©. However, it comes at one of the most crucial times of Breakthrough Ministries. Over past several months (particularly September through November 2014), I made personal visits to over 350 different businesses in Nanaimo (their owners, managers, employees or a little of both). This is the second of such visits, the first being made during the months of March through April 2014. Tallying the Nanaimo businesses plus the personal connections I have established through Reel Time Fishing Charters, the number of contacts now exceeds 400. I have notes detailing each visit.

With these initial contacts made, I am now moving forward with phase two of my ministry plan. I would like to deepen these connections on a more personal level. Some of these connections will be made through phone conversations. Most I hope to make through personal meetings. During these conversations, I will be sharing the additional services of Reel Time, namely, my ministry services as a registered chaplain in BC (this information is already printed on my business card). I hope to complete the majority of these conversations by the end of April. The remainder will be completed by the end of November 2015. Those who wish to become more connected to the services of Breakthrough Ministries will be invited to "like" the Breakthrough Face book Page, a communication tool I am currently exploring for the ministry at this point.

As a bi-vocational ministry of outreach and discipleship, one might wonder where all of this is going. Simply put, outreach and discipleship happen well within the context of a trusting relationship. I believe that I have laid healthy groundwork for trust relationships to grow (tilled the soil so to speak). It is here that I believe the Good News of our Gospel will begin to take root and grow through Life Transformation Groups or other avenues that God may open up. **As you and your council members receive this report, please keep me and this ministry in your prayers during this scary, exciting and crucial next phase.** A verbal report will be given at the March Classis as well as an update on the 2014-2015 benchmarks for Breakthrough Ministries.

January, 2015

A. YEARLY REVIEW

This past year has been one of major changes within Cascade Christian Counselling Association.

In our report of last year, it was mentioned how our Director Elaine Binnema was leaving our organization and that Penny Armstrong was hired as the new Director starting at the beginning of January. Penny was progressing along nicely when due to health reasons she had no choice but to tender her resignation by the end of 2014.

Our contract counselor for the Abbotsford office, Mike Ayers, has been kept busy for one day a week serving clients from the Abbotsford area and he will continue to function as a contract counselor in the year 2015. In addition to Mike, we also hired another contract counselor for the Surrey office, Brent Unrau. It was noted that a need had arisen for a male counselor to be available in the Surrey office. Both Mike and Brent have been wonderful additions to our staff here at Cascade. Our other counselor, Jan Bryant continues to travel north to Smithers once per month to serve the Bulkley Valley Christian School and counseling individuals from this area of B.C. As well, throughout this past year, Penny was able to continue her work at both our Surrey and Abbotsford offices.

B. NEW DEVELOPMENTS

Due to the resignation of our Director, Penny Armstrong, the Board of Cascade has made the decision not to hire a new Director at this time, but to hire another contract counselor to work in both the Surrey and Abbotsford offices. This new approach will be reviewed every three months to see how it is serving the clients that come to Cascade.

As a result of this new approach, we have hired another contract counselor, Hollie Tomkinson, who will serve clients in both the Surrey and Abbotsford office. We look forward for Hollie to start work the middle of January.

C. RECOMMENDATIONS

We ask for the following recommendations:

- a. That Classis encourage member churches to continue to remember our ministry in their pastoral prayers on a regular basis.
- b. That Classis encourage member churches to hold two collections annually for the work of Cascade Christian Counselling Association.

Classical update

BCSE and BCNW meeting March 3 and 4, 2015 Spring 2015

Greetings,

As I write, I anticipate meeting with CRWorld Missions board in Burlington in early February. Once again I will have the opportunity to hear about the work that God is doing through the CRC and particularly CRWM close to home and across the globe. I am serving my third year of a first term as a CRWM board member representing classis BCSE and BCNW. Too soon after retiring from years of service in Eastern Europe and returning to B.C. with his wife and team partner, **Frank Sawyer**, a long term CRWM missionary passed away this past summer into the presence of the Lord he served so faithfully. Pray for God's continuing comforting presence for Aria and their family.

Our Canadian director, **Steve Kabetu** continues his work out of the Burlington, Ontario, offices with committed staff, missionaries, volunteers and partners. Check out the January 2015 Banner for an article entitled <u>God is Not White</u> that includes part of his family story re- the denomination's Doctrine of Discovery taskforce.

Larry Lutgendorff, appointed last spring as Advancement Associate for CRWM Canada visited B.C. in April 2014, meeting with individual and group supporters of CRWM. Trish deJong, CRWM Missions Engagement Developer plans to be in B.C. in February to meet with Missions mobilizers, Missions committees and partners and ministry leaders. Churches within our BC classis receive regular news from Naji Umran and Anne Zaki and their family serving in Egypt. Continue to pray for them and others who serve in the epicenters of unrest in the Middle East. Originally from Langley, Nathan and Kimberly Boersema and their three children continue their life in Nicaragua, partnering with CRWM providing educational leadership in conjunction with the Nehemiah Centre.

Continue to pray for the **Salaam Project** as it provides training for ministry and outreach to the Muslim world. Recent extremist attacks in our country and beyond our borders cause us to cry out for counter actions in prayer vigils for peace and understanding across the globe.

At the early January writing this report, plans are shaping up to bring **Rev. Istifanus Bahago** to B.C. pending the approval of a Canadian visa for which we ask your prayers. In the fall of 2012 the CRC of Nigeria commissioned Rev. Bahago to serve as a Church Development Coordinator with the CRC in Sierra Leone replacing Rev. John Phiri who returned to Zambia. Rev. Bahago and his wife, Jemimah, relocated to Sierra Leone in January 2013 with two of their children but have taken a leave from SL because of the Ebola crisis. The Lord willing Rev. Bahago will be in Canada from February 25 to March 19, **travelling throughout B.C. from March 4 – 18**. It is the desire of BC/Sierra Leone Partnership and CRWM that Rev. Bahago visit with as many churches, groups and individual partners as possible during his time here including the B.C. classis meetings. B.C. CRC churches that are not presently partnered with CRWM missionaries are encouraged to consider this partnership.

Last but not least of all we ask for vigilance to bathe in deep prayer West African countries and particularly the **CRC** in **Sierra Leone** with its BC Classical Partnership. The Ebola crisis has spread disease from cities into country sides and the accompanying fear that goes far beyond the borders of the affected countries. At the time of writing there have been over 100 deaths in the Koinadugo district. The CRC community of Kabala and beyond are severely affected by limited health care, area quarantines and limited public gatherings and the closure of schools including the Kabala CRC Christian School. It has limited travel within West African countries and internationally.

Together with BC CRWM mobilizer, Ko Spyksma, I pray that our B.C. Classis gatherings may be an opportunity to share and celebrate God's way with His people in the CRC in our BC communities and beyond. God Bless.

Report to Classis BC North-West of the Christian Reformed Church: January 2015

Greetings from The King's University! We're pleased to have this opportunity to share the blessings we've enjoyed since our last report, and to look ahead to the exciting opportunities of 2015.

This fall, King's enrolled 715 students to study and be a part of our community for the 2014/15 academic year, which is up 21 students from last year and an all-time record high! It has been encouraging to see two consecutive years of positive enrolment growth. Increased investment in programs, such as the Leder School of Business and Community Engaged Research, enhanced student recruitment efforts and continually developing student care programs have helped recruit and retain more students than ever before in King's history. Thanks to all of our supporting community for helping to make this a reality.

During the summer of 2014 we received permission to change our name to The King's University – finally being able to drop "college" from the end. We were thrilled with this decision as being labelled as a "university" better reflects what King's truly is – a full-fledged university. We had our trade name legalized shortly after the announcement but are now in the midst of the process of officially having our government Act changed in the Legislative Assembly of Alberta. Having this Act changed requires the submission and approval of a private bill. This process was started in fall 2014 with Dr. Richard Starke, MLA Vermillion-Lloydminster, agreeing to sponsor our bill and submitting all required paperwork.. The private bill was not able to be introduced this past fall so we are continuing to pursue this and hope to have the bill introduced this spring. Please commit to pray for this process and for Dr. Starke and the Hon. David Dorward (the MLA for King's riding) who are working hard on our behalf. Pray for political will and favour with the Hon. Don Scott, Alberta Minister of Innovation and Advanced Education and other parliamentary staff members involved.

Over 500 people descended upon The King's University to celebrate Homecoming September 26-28, 2014. The festive weekend celebrated the 35th anniversary of the university and featured everything from alumni athletic games to a music alumni concert and an enormous carnival. On the Saturday night more than 300 people filled the gym for the annual Community Banquet and Silent Auction. Many Homecoming guests ended the weekend by joining in worship at Fellowship Christian Reformed Church the next morning.

King's welcomed over 280 guests at our fall open house in October. This was an increase of over 100 from last year and we received 74 applications for admission in one day! For the majority of guests it was their first visit to King's and 15% of these attendees made the decision to apply after they arrived on campus. If you know someone who may be interested in visiting King's, mark your calendars for the spring Open House on March 14, 2015. This is a wonderful opportunity for prospective students and interested community members to see what King's has to offer.

The King's community has been engaged in an extensive strategic planning exercise over the last year to create a document that will guide the university's next steps. We are working to clearly define our vision for the next five years and are prioritizing our goals for the future. There is a lot of excitement around what the future holds for this institution and we look forward to sharing our plans with our supporting community. We expect to complete this task with Board approval of the plan in March 2015. Please pray for this process and that God will guide the decisions that are being made.

As we enter a time of financial instability for the province of Alberta, we are budgeting very cautiously for the institution. We continue to use the resources that we have been blessed with in the most efficient and effective manner possible. As we

anticipate provincial government funding cuts to post-secondary institutions we reflect on the magnitude and significance of the generous funding that we continue to receive from our supporting community. Thank you to all of the churches in Classis BC North-West for confirming the value of the work that is being done at King's by giving generously through Ministry Shares and other offerings. These gifts represent a significant part of our budget each year. Your commitment to our students and King's mission to provide "university education that inspires and equips learners to bring renewal and reconciliation to every walk of life as followers of Jesus Christ, the Servant-King" is deeply appreciated. On behalf of the entire King's community, we would like to express our sincere gratitude.

It is made up of 7 small group sessions, based on the CBC's 8th Fire series and encourages all of us to walk the road of reconciliation with our Indigenous neighbours. The reforming Relationships art tour and the Truth and Reconciliation Commission (TRC) are coming to an end. The final TRC will take place in Ottawa May 31-June 3, 2015. The reforming Relationships tour will be there as well, for the final tour showing of Ovide Bighetty's artwork at a downtown Ottawa location (to be determined). The Canadian Aboriginal Committee will be in Ottawa to meet together and to mark the end of both the TRC and the art tour. From Ottawa, the art work will make its way back to Regina, to the Indian Metis Christian Fellowship, where the art tour began. We are so thankful to God for this art tour and for the conversations, relationships and the opening of hearts and minds toward each other that continue from this experience.

CAMC will continue to connect with the contacts that developed through the reforming Relationships tour. We hope these contacts will become champions for Aboriginal Ministry. These champions would keep their congregations aware of the Justice and Reconciliation work being done in the denomination and would be a way for congregations to connect directly with CAMC if they would like further resources and/or would like to find new ways to do justice.

This is our vision: to continue to find ways to connect with churches and communities and through these connections to develop ways to actively live out reconciliation with our First Nations brothers and sisters.
