The classis shall ensure the candidate meets the standards of character, knowledge, and skill adopted by Synod 2004." CRCNA Church Order, Article 23

CLASSIS MEETING ORIENTATION

Welcome to our classis meeting! Whether you are an experienced or a first-time delegate, please familiarize yourself with this orientation page.

Be sure to check out the "Meetings" tab on the Classis BCNW website, <u>www.classisbcnw.ca</u>, for classis meeting resources (some of which are mentioned below).

Classis

A classis is a group of churches within a geographical area that come together to seek, discern, and submit to God's will, offer one another mutual support and accountability, find ways to live out a collective calling in the region, and allow for a healthy and sustained connection to the wider denomination. There are 49 classes in the CRC: 11 in Canada, 37 in the United States, and 1 with congregations on both sides of the border.

A classis is a major assembly that has the authority to deal with matters that concern its churches in common and its decisions are binding on the churches in its region. The classis has the same authority over the council as the synod has over the classis. Classis BCNW consists of two delegates from each member congregation – normally a pastor and either an elder or a deacon. (In the CRCNA classes normally consist of three delegates from each member congregation: a pastor, an elder, and a deacon. For reasons of distance, Classis BCNW has its member churches send two delegates.)



The executive of classis consists of a president, vice-president, recording clerk, and the stated clerk. The executive rotates among the pastors of member churches and is appointed for each meeting by the Classis Ministries Interim Committee (CMIC) prior to the meeting of classis.

Duration of Classis Meetings

Classis meets twice a year: the first Tuesday and Wednesday of March, and the first Tuesday and Wednesday of October. (Tuesday: 1:00 p.m. to 9:00 p.m.; Wednesday: 8:30 a.m. to whenever we are done – usually around mid-day or early afternoon.) Ordinarily a workshop of some kind is held on the Tuesday evening.

The Classis Registration Form

All delegates are required to complete a Classis Registration form (available online on our classis website, https://www.classisbcnw.ca/meeting/classis-registration-form.cfm). This form will collect lodging, meal, and transportation information. If you are billeted by a member of the host church, be sure to advise your host of any food allergies you may have.

If you choose to use a hotel/motel, reimbursement is not supplied. You will have to seek reimbursement from your home church. If classis puts you in a hotel room because not enough billets were found, classis will then cover the hotel costs. In case of exceptional or reasonable circumstances a lodging expense may be approved by classis.

What to Expect at a Classis Meeting

- First time delegates are to sign the Covenant for Office Bearers.
- The Classis Agenda will, ordinarily, be in the hands of church councils one month prior to the actual meeting date of classis. It may also be found on our classis website.
- Delegates may be requested to serve in the following capacities:
 - Prayer: for the ministries of classis, or for the concerns of classis or individuals.
 - Pre-advice Committee: Pre-advice committees review expenses, overtures, and credentials and come with recommendations regarding the same to the floor of classis.
 - From time to time an overture of such significance may be forwarded to classis that it will require an advisory panel to meet ahead of the actual meeting of classis. For this and other reasons it is beneficial for the stated clerk and the CMIC to know who will be delegates well ahead of time.
- Though there is a degree of flexibility, classis abides by its own Rules of Procedure (ROP) and the
 rules of the CRCNA Church Order in conducting its meetings. The Classis Rules of Procedure can
 be found on our classis website. Church Order is determined by synod and is held in covenant by
 all Christian Reformed Churches.

What Classis Expects of its Delegates

- Be on time for all sessions of classis. Remain at classis until the meeting is formally adjourned. Delegates need to inform the chair or stated clerk if you must leave early, and give good reason to be excused. Dress code is business casual.
- Thoroughly familiarize yourself with the classis agenda. The assumption is that the agenda has been discussed at the delegates' local council meeting.
- Listen carefully to the discussions and deliberations and be prepared to make contribution with



words of advice, encouragement and/or questions.

- Delegates are expected to share the thoughts of their council on any particular agenda item but are not obligated to vote according to their council's wishes. Classis is a *deliberative* body and the freedom needs to remain for delegates to vote on the basis of the best information or perspective presented at classis.
- Refrain from speaking until the chair acknowledges your turn to speak. The delegates privilege
 of the floor is at the discretion of the chairman. A delegate may speak one to three times on any
 particular agenda item but no more than that. Do not repeat comments or observations that
 have already been shared.
- Be aware that classis is a deliberative body and may make decisions from time to time that you
 do not necessarily agree with. Strong objection to a decision of classis may be voiced by stating
 your objection. If you wish to have your objection recorded, you will have to submit a written
 statement (within 24 hours) indicating your objection and reason(s) why.
- Report to your church council the decisions made at classis.

Overtures

- An overture is a request for action made by an assembly to a higher assembly, or by an individual to their council.
- A council may overture classis. A classis may overture synod. Individual members of churches
 may only overture a classis or synod after first overturing their council and respective classis. A
 council may only overture synod after first overturing classis. Only when overtures are not
 acceded to, do individuals, councils, and classis appeal by overturing a higher assembly.
- Guidelines for the formatting & presentation of overtures to classis may be found in Appendix 1
 of the Classis Rules of Procedure (https://www.classisbcnw.ca/meeting/meeting-documents.cfm).



Stated Clerk Report to Classis BCNW August 2019

It has been my privilege to serve as stated clerk for five months now. These past five months have been a time of learning and growing into the position, and developing a greater appreciation for all that Andy de Ruyter did both as stated clerk and chair of the CMIC. In October 2018 classis approved separating those two roles after Andy was finished, and in April Ken Vander Horst was elected as chair of the CMIC. We have been slowly (and amicably) figuring out how to function in roles that are now filled by two people rather than one. I am grateful for Ken's wisdom, and for the support of the CMIC and other members of classis and the denomination. Thanks to all who have helped me, and to God who continues to empower me by his Holy Spirit.

Some of the things I have been involved in these past five months, besides answering innumerable emails, managing the website, and setting up the many details of this classis meeting:

- Served as clerk on four committees/teams of classis: preparing the agenda, participating in meetings, taking the minutes: The Classis Ministries Interim Committee (CMIC), The Going Forward Team (GFT), The Funding Team, The Board of the CRC of Richmond (the CMIC functions as this board and meets annually in March).
- Was an active participant in preparing the Funding Team Proposal and the Regional Meeting Proposal that will be discussed at this classis meeting.
- Attended two meetings with Classis BCSE to work on items of mutual consideration.
- Applied for a marriage license for Commissioned Pastor Angela Elliot (Nelson Ave. Community Church) and a temporary license for Commissioned Pastor Bert Adema from Regina, SK.
- Participated in two stated clerks video meetings and a number of Canadian stated clerks' email conversations.

March 2019 Classis Meeting:

Expenses for the March 2019 Classis Meeting were: travel - \$5,755.31, food - \$2,074.68, for a total of \$7,829.99.

Logistics

Thank you to delegates and churches for using the online credential and delegate registration forms, and for doing your best to keep travel costs down by carpooling and booking flights as early as possible. *Note:* in March classis approved the following changes to the travel policy:

- Airline transportation should be used for long-distance travel. If a traveler elects to drive for long-distance travel, the mileage/car rental reimbursement should not exceed the average cost of an airplane ticket to that destination. Please consider car rental and carpooling to reduce cost.
- If flying, classis will pay the cost for seat selection.

Classis Ministries Interim Committee (CMIC) Report to Classis BCNW: August 2019

The mandate of the CMIC is to "act for classis between meetings in matters that require immediate action". The CMIC has met twice since the March 2019 meeting of classis and has had a number of email conversations and votes. The following minutes of the CMIC are available upon request by member churches from the stated clerk:

MATTERS FOR INFORMATION

1. **Chair of the CMIC:** At its April meeting the CMIC appointed Rev. Ken Vander Horst as chair of the CMIC.

2. Classis Agenda Items:

- a. Recording Clerk: As Kathy Smith has moved into the role of stated clerk, and is no longer the recording clerk at classis meetings, it was decided to follow the Classis BCNW Rules of Procedure (ROP) which state that "each minister, or commissioned pastor, shall successively serve as Vice-President, President, and Recording Clerk". Having said this, there is always the option for someone to serve on a consistent basis as the Recording Clerk if someone would want to volunteer.
- b. **Logo:** Thank you to Timothy Choy, Media Coordinator at The Tapestry, who designed the logo found on the front page of the Agenda.
- c. Classis Workshop: Chris de Vos, from The Colossian Forum, has been invited to come and lead a devotional workshop on Conflict as Opportunity on the Wednesday morning of classis. Chris will also be leading a training session at The Tapestry on The Colossian Way on the Thursday and Friday following classis.
- d. **Funding Team Proposal:** The Funding Team submitted a Proposed Model and Rationale for Classis Ministry Funding. This proposal can be found on page 24 of this Agenda and in the *Meeting Documents* zip file. It will be discussed on Wednesday afternoon.
- e. **Ministry Shares:** Proposed classis ministry shares for 2020 were approved and can be found on page 22 of this Agenda, and in the *Meeting Documents* zip file. The proposed ministry shares will be discussed after the treasurer's report.
- f. **Immanuel CRC's Presentation:** In consultation with the Oversight Committee, Immanuel CRC has been granted an hour to address classis on Wednesday morning. A document will be forthcoming to all delegates giving more information on this presentation.



g. Nominations:

- i. COD: The CMIC recommends Andy de Ruyter as the nominee to the Council of Delegates (COD) for one more term. Andy served on the Board of Trustees for three years, and has served on the COD for two years. He is on the executive and has requested this additional term to see some items through to completion.
 Having said that, if churches wish to submit the name of another nominee, they are welcome to do so. Please contact Ken Vander Horst at kvhorst@gmail.com if you wish to do so.
- ii. **License to Exhort:** The CMIC recommends that Neil Lettinga's license to exhort be renewed for another two years. Neil and Virginia have returned to Prince George after spending a year in Ontario with Guelph Campus Ministry, a Christian Reformed campus ministry. They hope to remain in BC until at least 2020 and Neil always enjoys preaching in our churches.
- iii. **Delegates to Synod:** Churches are requested to send in their nominees for elder, deacon, and a 4th delegate (either pastor, elder, or deacon) to synod to Ken Vander Horst at kwhorst@gmail.com.
- 3. **Janina Mobach Krabbe:** Janina Mobach Krabbe, formerly church planter with downtown friends, has been issued a letter of call from The Tapestry to serve as Community Chaplain, working bivocationally as a Project Manager in the School of Nursing at UBC, as a Local Ministry Leader with Resonate, and as a Community Chaplain at Mosaic Church. Janina, working alongside Engage Vancouver and Resonate, will also be exploring the possibility of a CRC Indigenous Centre or network.

The CMIC affirms that this fits with Church Order, Article 12-b, which states:

A minister of the Word who (1) enters into the work of missions, chaplaincy, or specialized transitional ministry ... shall be called in the regular manner by a local church, which acts in cooperation with the appropriate committees of classis or synod.

As per Church Order, the letter of call will be signed by Rev. Andrew Beunk in the role of classical counselor.

- 4. **Classis BCSE:** A number of meetings have been held this past year with Classis BCSE regarding the shared ministries of BC LDN, Safe Church, and the Ministry to Seafarers. We continue to work towards being properly compliant with the CRA in matters of oversight and financial accountability. We have been working the law firm De Jager Volkenant in that regard and will soon be signing some agreements that will properly reflect our joint relationship.
- 5. **Seafarers Bank Account:** The classis treasurer, David Pel, is also working with the De Jager Volkenant law firm on setting up a separate bank account for the Ministry to Seafarers so they can accept cheques addressed to their ministry.
- 6. Financial Approvals:
 - a. **FaithCARE Conference:** It was approved to spend \$500 from the Safe Church Fund to assist Smithers CRC in sending two people to this conference in Langley.



- b. **Safe Church Conference:** It was approved to spend up to \$4,000 from the Safe Church Fund towards expenses for the Safe Church Equipping Conference: Sexual Brokenness, Pornography, and the Church taking place later this year.
- 7. **Student Fund & Bi-vocational Ministry:** According to the current student fund policy, classis only supports those intending to go into full-time ministry. The Student Fund Committee was given the go-ahead to rewrite the criteria for funding support to include those who are considering bi-vocational ministry and bring it to classis for approval.
- 8. **Going Forward Team:** The Going Forward Team met on April 10, 2019. Some of the items that were discussed and brought forward to the CMIC:
 - Worked with Tim Choy, media coordinator at The Tapestry, to develop the classis logo you see at the beginning of the agenda.
 - Decided to continue having a theme for each classis meeting based on the Values found in our Mission Statement. Themes so far:
 - March 2019: Leadership Development
 - October 2019: Authentic Community
 - Decided to continue with the current reporting structure: classical committees report at every classis meeting, denominational and other agencies report once every 2-3 years.
 - Considered bringing a proposal to classis that examinations could be done via video, but after feedback from the CMIC stepped back from that idea and affirmed the current practice of fitting examinations into the existing meeting schedule.
 - Brought a proposal to the CMIC that classis consider holding a one-day regional classis meeting.
 The CMIC has developed that proposal and it will be discussed as part of the agenda of this classis meeting.
 - Committed to meeting once between each classis meeting for the next year or so, after which we will evaluate the continued need for this committee.
- 9. **Zoom Video Conferencing:** Classis has an account with Zoom Video Conferencing. If a church or pastor wishes to use this account for a classis or denominational meeting, please contact the stated clerk at kathy.bcnw@outlook.com. As long as that time slot is available, she will set up the meeting for you and issue an invitation you can send to your meeting participants.
- 10. Update to the Appendix of the Rules of Procedure: The CMIC approved the following clarification to be added to Appendix 1, "Formatting and Presentation of Overtures to Classis", point D, Procedures: Overtures to synod are due to the CRCNA executive director's office no later than March 15. Overtures or communications received after the March 15 deadline are accepted if they relevant to reports found in the printed synod Agenda. As classis meets the first week of October and the first week of March, overtures presented at either classis will meet this deadline.
- 11. **Synodical Decisions Affecting Classis:** The following were received for information as no action is needed on them at this time. More information will be coming from the denomination in the future.



a. Abuse of Power:

- i. Classes are instructed to develop a strategy to train officebearers and key church leaders to be alert to power dynamics within the communities they serve and to be equipped to prevent abuse of power.
- ii. Classes must also ensure that survivors of abuse within their classis have access to appropriate counseling services.
- b. **Reimagining Ministry Shares:** Classis will be more involved in this going forward, but not for at least another year.
- c. **Synodical Delegates:** Classis is encouraged to provide remuneration to delegates who are financially disadvantaged through service to synod. Each classis can determine a fitting amount of remuneration on the basis of its location. (Classis BCNW makes provision for this already in our ROP.)

RECOMMENDATIONS REQUIRING THE APPROVAL OF CLASSIS

1. Membership of the CMIC

According to the classis ROP, membership of the CMIC "shall consist of seven members: The chairperson, the stated clerk, the classical treasurer, the chair of the Student Fund Committee, the elected alternate stated clerk, two at-large members, and the Safe Church Team Coordinator in an ex-officio capacity." Currently the CMIC consists of six members: the chairperson (who is also the alternate stated clerk), the stated clerk, the chair of the SFC, and two at-large members.

Motion: That classis change the ROP to allow six members on the CMIC rather than seven.

2. Remuneration of the Stated Clerk and Treasurer

Motion: That classis increase the remuneration of the stated clerk and treasurer from \$5,600 to \$5,700, as per the Classis' Rules of Procedure, which state: *Classis shall provide an honorarium to the Stated Clerk and Treasurer. This honorarium shall be reviewed every two years by the CMIC and brought in line with a mean average for all Canadian classes (if needed).*

3. Regional Classis Meeting Proposal

Upon a recommendation of the Going Forward Team that classis consider meeting regionally on occasion (that is, each region meet in their own location) a draft proposal has been prepared by the CMIC. This proposal can be found on page 18 of this Agenda and in the *Meeting Documents* zip file. **Motion:** That classis accede to the Regional Classis Meeting Proposal and, as a first step, spend the Wednesday of the March 2020 meeting in the regional meeting structure.

Motion: To approve the work of the CMIC.

Proposal for Regional Classis Meetings March 2020 and March 2021 Submitted by the Classis BCNW CMIC to the October 2019 Classis Meeting

Preamble:

Classis BCNW exists to encourage, equip, and empower congregations and ministries to bear witness to the gospel of Jesus Christ and seek first God's Kingdom.

A few years ago, we had an extra day of classis to wonder together about classis. From that time, we worked on a mission statement, and talked honestly with one another about some of the questions, concerns, naggings, and wonderings about how we were functioning. Some of those conversations included: how we decide, fund, and continue to support ministries through ministry shares; whether there was a way to do regional ministry in our three distinct areas; how to grow and be more of a spiritual community as we go about our business.

A *Going Forward Team* was initiated to identify areas of adjustment. This team has done a number of things, including helping classis name its values: Prayerful Dependence on God, Authentic Community, Disciples Making Disciples, Leadership Development, and Covenantal Relationships.

One of the recommendations the *Going Forward Team* made to CMIC was to have classis hold regional classis meetings in March 2020 as an experiment (i.e. have three meeting locales connected via video conferencing). This idea recognizes the unique three-region make-up of Classis BC Northwest, allows for specific topics of learning and discussion within each region, and could enhance the relational connection of delegates in Northern BC, Vancouver Island and the Metro-Vancouver areas. Additionally, with available technologies such as Zoom Conferencing, we would still be able to remain connected with the whole classis for decisions that would need to be shared.

Recommendation to Classis:

As a way of experimenting, CMIC recommends a three-step approach, each step to be followed by a time of debriefing to determine if the next step is to be taken.

- 1. That classis hold its March 2020 meeting in person, and spend Wednesday with the regional meeting structure.
- 2. That the March 2021 meeting be held in the three regions, with a portion of the meeting conducted via video conferencing.
- 3. After debriefing the above two steps, that consideration be given to *normally* hold the March classis meetings remotely.

Grounds:

- 1. Switching to a regional meeting structure will give us more opportunity to practice our values.
 - a. <u>Prayerful Dependence on God</u>: Gathering in our regions will create the space for discernment of God's calling for a more localized context. It creates more opportunity for churches to bring their discerned callings to for a "check" by the larger CRC community. It has the potential to deepen churches relationships of mutual prayer support for one another.
 - b. <u>Authentic Community</u>: Smaller groups of delegates will have more opportunity to share, pray for one another, and be encouraged and know one another.
 - c. <u>Disciples Making Disciples</u>: Meeting with more of our officers (a Minister, Elder, and Deacon would be delegated) will enable our classis and churches to be faithful to God's mission and foster more creativity in how it is lived out.
 - d. <u>Leadership Development</u>: We foresee that better funding, training, and support will happen as regions take more ownership in naming, designing, and providing for their own felt needs in this area.
 - e. <u>Covenantal Relationships</u>: We believe that by meeting in regions, we are committing to be more fully present to and with one another in ministry.
- 2. Switching to a regional meeting structure will give groups time to focus on regional concerns and ministry in a deeper way.
 - a. It will give Regional Pastors time at the meeting to engage with the delegates in a deeper way than simply reporting. Examples:
 - Possibly do a session on the Birkman Assessment Tool (i.e. allowing Regional Pastors time to connect and lead the gathering through CRC recommended tools and material).
 - ii. Provide delegates from each congregation an opportunity to share joys, concerns, and best practices, and spend time together in prayer.
 - b. It will provide opportunity for regional delegates to discuss, plan, and evaluate, as appropriate, regional ministries.

If regions needed help on where to begin, these questions could be used:

- i. What could we do collaboratively as regional churches together? (Discerning God's will for regional partnership)
- ii. How can we learn from each other and be more productive in our local setting? (Being a Learning Community- what do we want to learn from one another, and what do we have that we could share?)
- iii. What are local issues in our region and how are they affecting us?(Discerning if there is a clear mutual need the Spirit is wanting the church to address)
- iv. What are the challenges of doing ministry in our region, and how can we overcome them?

(How might we support one another?)



- v. What resources are available in our region that we could be tapping into?
- vi. How can we be involved in outreach with other churches and organizations?
- c. It will provide opportunity for local ministries (e.g. C.R. Campus Ministry at UNBC in the North) to engage with the delegates in their region in a more productive and encouraging way than just reporting.
- d. It will provide opportunity for other ministries in each region (not necessarily classis ministries) to connect with the churches in their region.
- 3. While there would still be costs involved, regional meetings will provide financial and resources savings as compared to our current meeting structure (all delegates meeting in the Lower Mainland). Furthermore, as stewards of creation, we recognize that this model moving forward would lessen the carbon footprint of our classis meetings.
- 4. Conducting a portion of the meeting via video (in March 2021) will provide an opportunity for classis to try this method of meeting and evaluate if this is something we could do for other agenda items (e.g. examinations).
- 5. Our fall meetings include ministry share conversations, which we believe is better done in person. Therefore, we wouldn't want our fall meeting to be done remotely. Furthermore, we know not all of our learning and working together in ministry is regional.

CMIC's Notes on Planning (post 2020)

1. Logistics:

- a. All regions meet on the same day for a one-day meeting and follow basically the same administrative agenda to start and then look at localized issues and discussions. We would meet together via video for a portion of the meeting: e.g. for the stated clerk/CMIC report, financial report, AGM, overtures, and any other mutual business that may be required.
- b. Each congregation would send three delegates (pastor, elder, deacon).
- c. A planning committee will be formed within each region to set their own agenda. The CMIC members from each region will be part of the planning and leadership of these meetings, possibly with the regional pastor. The stated clerk will also be involved in the planning of all three to ensure needed agenda items are covered, the video link (via Zoom) is set-up, minutes are taken, etc. Planning committees would both plan the meeting and debrief afterwards.
- d. Classis will pay all logistical costs (food, transportation, and lodging if necessary, according to our current standards and protocol) from the Classical Expense Fund. Two delegates from each region will be assigned to collect receipts from the regional delegates, compile them, and forward them to the stated clerk.

2. Questions/Needs

a. The March meeting is pivotal for gathering goals, hopes, dreams, and ministry focus areas. We may need to do some follow-up at the fall meeting to make sure we have enough for the regional meetings in the next spring.



- b. Do we consider moving the remote meeting to a Saturday? What time does the meeting start and end? Do we consider having two of these a year, with one in person meeting (matching other regions)?
- c. Who are the centrally located host church willing to provide space, equipment, and organize meals in each region?
 - i. Lower Mainland: Use those churches who normally don't host because of distance from the airport, e.g. Maple Ridge, The Tap Mundy Park
 - ii. Northern BC:
 - iii. Island: Nanaimo CCC
- d. Leadership: need facilitator/host and recording secretary at each site.
- e. Video: need a designated video person at each site i..e. not a delegate. The video set-up will all need to be worked out ahead of time and tested before the date. A back-up plan may be required (i.e. conference call; try again later in the day; ??).
 - i. Does this mean one big call/screen for each region, or individual screens?
 - ii. Do we need a chat system to pass information in writing (at least among the CMIC reps in each region?)
 - iii. How would voting work? E.g. AGM via pre-meeting ballot? Other?
- f. Food: The host church would be responsible for providing the meal(s) and refreshments and submitting receipts to the stated clerk.
- g. What might be the effect on the October meeting? Can we do the AGM in October?

- Approval of the **Classis Expense Fund** includes approval for the following:
 - \$500 to support the biennial New Pastors to Canada Gathering (for Ministers of the Word)
 - o \$400 to support the annual Youth Ministry Champions Retreat

- Classis would be willing to fund other requests (e.g. Conference for Pastors Wives) if a specific request came from a local church.
- Funding for **The Bridge App** is not included in this proposal: The CMIC is recommending that churches pay individually for The Bridge App from now on, at a cost of \$424/congregation. With 13 churches using the app, and some of those not planning to continue using it, it does not make financial sense for classis to pay as the cost to classis is \$6,000/year (i.e. more than \$424/church).
- In 2019 there are 2,309 members, so \$1 = \$2,309. Membership will be slightly different for 2020; and the small church ministry share reduction drops the \$4 amount slightly.

Proposed Model and Rationale for Classical Ministry Funding Presented by the Ministry Funding Team, Classis BCNW August 2019

Background/History:

- In 2017 the Classis Ministry Funding Team began meeting with the mandate to provide Classis BCNW with some criteria/rationale regarding the ongoing funding of classical ministries. The concern had been raised that classis had no effective criteria for a) determining ongoing classical ministry shares, other than approving the annual budgets of these ministries, or b) approving new ministries.
- In April 2018 this team released the *Report on Funding Classical Ministry Shares**, and asked church councils and classis ministries for written feedback.
- At the March 2019 classis meeting an hour was set aside to discuss this report, guided by another document, Funding Classical Ministry Shares - Some History and A Guide to Discussion at Classis*.
- Out of the feedback we have received from classis to both of those documents we present the following proposal.

(*Note: both of these documents are available from the stated clerk.)

Proposed Model for Ministry Funding:

- Currently there are four types of ministries in Classis BCNW, with different levels of funding for each type.
 - 1. Denominationally mandated ministries that receive full funding from classis. E.g. Safe Church Ministry, the Student Fund (Safe Church provides education, consultation, and helpful, direct engagement with churches in crisis when there is a failure of leadership that has congregation-wide implications. The Student Fund provides assistance to those studying towards ordained ministry in the CRC.)
 - 2. Ministries birthed through classis that receive partial funding from classis. E.g. BC LDN, Campus Ministry at UNBC, Ministry to Seafarers.
 - 3. Ministries that are birthed through a local church and receive partial funding (often start-up funding) from classis. E.g. Kwantlen Chaplain (The Tapestry), Chaplain and Refugee Support Mobilizer (1st CRC, Vancouver), Mosaic Ministry to International Students (New Westminster CRC).
 - 4. Church Plants (*none currently in BCNW*) that have received partial funding from classis. E.g. downtown friends.
- Going forward, new ministries are to be birthed through a local church or partnering churches
 unless they are a denominationally mandated ministry, as per Synodical or Church Order
 requirement, like Safe Church and the Student Fund.
- Those beginning new ministries are asked to consider the support of churches within classis and also outside support: e.g. private, ecumenical, community, etc.



- To begin, we are proposing two different kinds of funding support:
 - 1. Incremental Decreased Funding
 - 2. Grant Funding
- There will be three-year initial support, upon successful application and approval, followed by a ministry review.
- There will be a two-year period of transition before this proposal takes effect. Individual transition plans will be formulated in consultation with each of the ministries. (Full implementation by January 2022.)
- Each ministry will have a contract with Classis BCNW (a CRA requirement).

Rationale:

- Our current model for classical ministries is not sustainable long-term. Support for classical
 ministries is plateauing, if not decreasing. In presenting this proposal we are being proactive in
 finding ways to fund ministries in a sustainable way into the future.
- Fundraising is "friend" raising: it is about relationships. Many churches do not currently have relationships with the classis ministries.
- With regards to church planting, it is not the classis or denomination that should be planting churches. Rather, churches plant churches; classis and the denomination come alongside to provide support, which could include financial.

Principles to Receive Funding

(Note, these principles are initial thoughts. The application and review processes need to be worked out in greater detail.)

- 1. Application, to receive funding:
 - a. The ministry is to be birthed through a local church or partnering churches. If it is not, it must clearly fit under the umbrella of a denominationally mandated ministry.
 - b. The ministry must "bear witness to the gospel of Jesus Christ and seek first God's Kingdom".
 - c. The ministry must demonstrate that it falls under the five Classis BCNW Values:
 - i. Prayerful Dependence on God
 - ii. Authentic Community
 - iii. Disciples Making New Disciples
 - iv. Leadership Development
 - v. Covenantal Relationships
 - d. A funding recommendation must be included in the application, along with the type of support being requested: i.e. Incremental Decreased Funding or Grant Funding.
 - e. The ministry must demonstrate that outside sources of support have been considered and/or arranged.
 - f. Ministry review principles and goals must be built into the application.



- 2. Review, after 3 years, as part of the process to request continued funding:
 - a. Ministry reviews will include outside input, a funding recommendation, and measurable goals.
 - b. The five Classis BCNW Values are to be part of the review process.
 - c. The following considerations are to be part of the review process:
 - i. Alignment: How does this ministry align with other ministries and the Mission and Values of classis?
 - ii. Effectiveness: What tangible steps are in place that show measurable ways in which the ministry is effective in accomplishing its mission?
 - iii. Partnership: Are there ways the ministry's relationship with local congregations and with classis can be strengthened for a more effective partnership?
