- 4.1 Status of Rev. Mary-Lee Bouma / CO Art. 17, c.:
 - c. A minister of the Word who has been released from active ministerial service in a congregation shall be eligible for call for a period of two years, after which time the classis, with the concurring advice of the synodical deputies, shall declare the minister to be released from the ministerial office. For weighty reasons the classis, with the concurring advice of the synodical deputies, may extend the eligibility for call on a yearly basis.
- 4.2 Executive Session Church Order Article 17: Smithers CRC / CO Art. 17, a., b.:
 - a. Ministers who are neither eligible for retirement nor worthy of discipline may for weighty reasons be released from active ministerial service in a congregation through action initiated by themselves, by a council, or jointly. Such release shall be given only with the approval of classis, with the concurring advice of the synodical deputies, and in accordance with synodical regulations.

CLASSIS MEETING FAQs

Welcome to our classis meeting! Whether you are an experienced or a first-time delegate, please familiarize yourself with this orientation page. Be sure to check out the "Meetings" tab on the Classis BCNW website, www.classisbcnw.ca, for classis meeting resources (some of which are mentioned below).

What is a Classis?

A classis is a group of churches within a geographical area that come together to seek, discern, and submit to God's will, offer one another mutual support and accountability, find ways to live out a collective calling in the region, and allow for a healthy and sustained connection to the wider denomination. There are 49 classes in the CRC: 11 in Canada, 37 in the United States, and 1 with congregations on both sides of the border.

A classis is a major assembly that has the authority to deal with matters that concern its churches in common and its decisions are binding on the churches in its region. The classis has the same authority over the council as the synod has over the classis. Classis BCNW consists of two delegates from each member congregation – normally a pastor and either an elder or a deacon. (In the CRCNA classes normally consist of three delegates from each member congregation: a pastor, an elder, and a deacon. For reasons of distance, Classis BCNW has its member churches send two delegates.)



The executive of classis consists of a president, vice-president, recording clerk, and the stated clerk. The executive rotates among the pastors of member churches and is appointed for each meeting by the Classical Interim Committee (CIC) prior to the meeting of classis.

What Should I Expect at a Classis Meeting?

- First time delegates will be asked to indicate agreement with the Covenant for Office Bearers.
- The Classis Agenda will, ordinarily, be in the hands of church councils one month prior to the actual meeting date of classis. It will also be found on our classis website.
- Though there is a degree of flexibility, classis abides by its own *Rules of Procedure (ROP)* and the rules of the *CRCNA Church Order* in conducting its meetings. The *Classis Rules of Procedure* can be found on our classis website. *Church Order* is determined by synod and is held in covenant by all Christian Reformed Churches.

What Does Classis Expect of its Delegates?

- Be on time for all sessions of classis. Remain at classis until the meeting is formally adjourned.
 Delegates need to inform the chair or stated clerk if you must leave early, and give good reason to be excused. Dress code is business casual.
- Thoroughly familiarize yourself with the classis agenda. The assumption is that the agenda has been discussed at the delegates' local council meeting.
- Listen carefully to the discussions and deliberations and be prepared to make contribution with words of advice, encouragement and/or questions.
- Delegates are expected to share the thoughts of their council on any particular agenda item but
 are not obligated to vote according to their council's wishes. Classis is a *deliberative* body and the
 freedom needs to remain for delegates to vote on the basis of the best information or perspective
 presented at classis.
- Refrain from speaking until the chair acknowledges your turn to speak. The delegates privilege of
 the floor is at the discretion of the chairman. A delegate may speak one to three times on any
 particular agenda item but no more than that. Do not repeat comments or observations that have
 already been shared.
- Be aware that classis is a deliberative body and may make decisions from time to time that you do
 not necessarily agree with. Strong objection to a decision of classis may be voiced by stating your
 objection. If you wish to have your objection recorded, you will have to submit a written
 statement (within 24 hours) indicating your objection and reason(s) why.
- Report to your church council the decisions made at classis.

What is an Overture?

- An overture is a request for action made by an assembly to a higher assembly, or by an individual to their council.
- A council may overture classis. A classis may overture synod. Individual members of churches may only overture a classis or synod after first overturing their council and respective classis. A council may only overture synod after first overturing classis. Only when overtures are not acceded to, individuals, councils, and classis appeal by overturing a higher assembly.

Stated Clerk Report to Classis BCNW: March 2021

Welcome to the March 2021 meeting of Classis BCNW! It has been my privilege to serve as stated clerk of classis for two years now. Thank you to Ken Vander Horst (chair of the CIC), the members of the CIC, and to the many others who have supported me and provided wisdom and advice when it was needed.

- 1. How I have Spent My Time: Some of the things I have been involved in these past five months:
 - Sent and received numerous emails.
 - Had a number of one-on-one phone conversations with pastors, church leaders, and personnel
 of classis.
 - Set up the many details of this classis meeting and the special classis meeting in November to examine then-candidate Hyung-Jun Kim.
 - Maintained and updated the classis website, including making the CMLT/SFC page more prominent than it had been.
 - Sent thank you cards to those who had finished serving in volunteer positions for classis.
 - Served as clerk or chair on two committees/teams of classis: The Classical Interim Committee (CMIC) and The Board of the CRC of Richmond (the CIC functions as this board and meets annually in March). I am also a member of the Classical Ministries Committee, which will have had its first meeting by the time classis meets.
 - Have begun sorting through a filing cabinet full of old files and records from when Rev. Peter Brouwer was stated clerk (mid '90s-early '00s).
 - Prayed regularly for the pastors and churches of classis, and did what I could to facilitate the flow of communication.
 - Arranged for a marriage registration for Rev. Hyung-Jun Kim.
 - Updated the marriage registrations for a number of current and past ministers in classis.
 - Participated in a number of video meetings with Al Postma and other stated clerks, particularly
 on Zoom meeting best practices. Participated in a video meeting with all the stated clerks in
 Canada and the US in lieu of our biennial in-person gathering. And participated in a number of
 Canadian stated clerks' email conversations on various issues.
 - Arranged pulpit supply for Victoria CRC for three Sundays in January and February, although in the end it was not needed as the congregation attended the virtual services of Christ Community Church in Victoria, and they now have interim pastors: Neil & Virginia Lettinga.
 - Worked with Ken Vander Horst on updating the Classis Rules of Procedure, and prepared a report on this for the Agenda.
- **2. October 2020 Classis Meeting:** As the October meeting took place via Zoom, there were no expenses requested for this meeting.

5. Denominational Ministry Shares: All of our churches responded to the denominational ministry shares pledge request. Pledged donations are down 7.4% compared to 2019 donations.

Grounds:

- Doing examinations this way would shorten the amount of time needed for a candidate examination at classis meetings.



The candidate, the examiners, and one of the synodical deputies from our most recent exam
found this format to be more personal and intimate, and two specifically recommended its
continued practice.

16. Membership on the CIC

At the October meeting of classis, CIC was tasked with reviewing our current membership.

CIC Membership as per the Rules of Procedure

Membership shall consist of six members: The Chairperson, the stated clerk, the Classical Treasurer, the chair of the Student Fund Committee, the elected alternate stated clerk, one at-large member, and the Safe Church Team Coordinator in an ex-officio capacity. An attempt should be made to have Membership include representatives from the Northern, the Island and the Lower Mainland churches.

- Stated Clerk: Kathy Smith (Lower Mainland) 2022 (1)
- Elected Alternate Stated Clerk: Ken Vander Horst (Northern region) 2022 (1)
- Treasurer: David Pel (Lower Mainland) 2023 (9)
- Student Fund chair: Vic Chen (Lower Mainland) 2023 (4)
- At-large member(s): Trevor Vanderveen (Lower Mainland), Chelsey Harmon (currently Lower Mainland, formerly Island) both 2022 (1)

As per our Rules of Procedure, there are 5 required seats (based on roles above) and the rest of the committee is made up of at-large members; the ROP also call for prioritizing regional representation. All of the positions are elected or affirmed via classis voting. Certain positions, such as the Stated Clerk, Treasurer, and Student Fund Chair are decided independently from the CIC itself.

Action: Currently, a member of CIC has moved to a new region, so we no longer have an Islander serving on CIC. CIC asks for the nomination of someone from the Island to serve on CIC. We can either increase our membership to previous levels and have 7 members of CIC, or one of our at-large members can resign. If a member from the Island does not join CIC, then we will prioritize that region when the current at-large members' terms are up.

Recommendation: We do not recommend changing our Rules of Procedure regional priority at this time.

Grounds:

- Covenantal Relationships
 - Our current practice is in alignment with our Rules of Procedure for all of our classical ministry practices: we prioritize regional representation across all of our classical committees.
 - Further, we identify as regions and divide the labour of classis (regional pastoring, pulpit supply, church visiting) as regions and have moved in this direction for the structure of our classis meetings as well. This has been a significant project the classis undertook via discernment and the Going Forward Team.



- Prayerful Dependence on God
 - Our current practice was the result of thorough discernment work as a classis.

Encouragement: If any churches believe it necessary to revisit this matter, we encourage them to overture classis regarding our Rules of Procedure. If classis believes the matter should be further investigated, we would like a more thorough mandate to review not only the ROP but the makeup of our local congregations and practices around the denomination, etc.

19. Rule Changes

Motion: That the following be added as point A. to XII. Rule Changes (p. 16)

Classis delegates, and church councils, are to be familiar with the Classis Rules of Procedure. When there are questions or concerns about process, the Rules of Procedure are appropriate and apt. (March 2020 Minutes, 3.1.6)

Grounds:

• This statement was approved at the March 2020 classis meeting, but not ruled to be entered into the ROP at that time.



20. Overtures

At the March 2020 meeting of classis, the CIC was tasked with putting together a proposal regarding procedure for future overtures, to clarify confusion as to which motion takes precedence when discussing an overture: the motion of the overture advisory committee or the motion of the overture itself. Overture: Delay discussion of the report from The Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality until Synod 2022

I. Background

In early November 2020, the CRCNA released the final report from *The Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality*, to be considered at Synod in June 2021. This report, 175 pages in length, represents 4 years of work from the committee and addresses a widerange of topics pertaining to human sexuality, making a number of significant conclusions on those topics which the report authors themselves acknowledge may be controversial amongst CRCNA congregations. In response to this report, the CRCNA invited and encouraged councils to review and carefully study the report and offer feedback through due process if they so wished.



This due process, as stated by the CRCNA, means that "an overture or communication first needs to be processed through the council and then through the classis, after which it should be submitted to the Synodical Services Office no later than March 15, 2021, to be included in the printed *Agenda for Synod*." In order to be considered by Classis BCNW, this means overtures from individual councils must be submitted by January 22, 2021. In summary, this gave the congregation and council of First CRC Vancouver approximately 3 months to read, digest, discuss, and respond to a weighty report that we had not previously engaged in any way.

To accompany the report, the CRCNA's Pastor Church Resources released a *Challenging Conversations Toolkit*, with a recommendation in the report itself that churches be encouraged to make use of this toolkit "to help small groups study and discuss aspects of the committee's report which may be controversial." While the Toolkit explicitly states that the purpose of the conversations is "not to make a decision about how our congregation should formally respond to the study committee's report," it *also* states that "an additional result of these groups is that they may provide important insight or context for the council should it decide to take any action. In other words, we hope that what happens in these groups informs any decision the council might make in the future." First CRC Vancouver also holds this hope, as evidenced by its decision to promote the toolkit on a timeline theoretically amenable to overture submission dates.

However, fulfilling this hope has proven difficult, as the toolkit is designed for 9 sessions, with the flexibility to reduce this to a minimum of 5 if necessary. Not until the last session is feedback gathered for church councils.

II. Overture

The Council of **First CRC Vancouver** overtures Classis BCNW to overture Synod to delay discussion of the report from *The Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality* until Synod 2022.

Grounds

- 1. The release of the report in the middle of a pandemic, with congregations and councils pivoting almost constantly due to changing restrictions, makes the timeline for proper congregational and council discussion that could actually lead to structured response to Synod (whether communications or overtures) unfeasible.
- 2. The Challenging Conversations Toolkit was not released in final form until early December, leaving churches to gather participants in the middle of the Advent and Christmas seasons, and making it almost impossible for feedback from participants to inform Council's actions in any meaningful way prior to Classis BCNW's January 22 overture deadline.

- 3. Practically, the sheer length of the report as well as its academic intensity and theological complexity demands significant time from its readers. Pastorally, the weightiness of the issues and the significant implications of the report's recommendations for the unity of the church and the love of its members asks for careful and deliberate conversation, which cannot be rushed. In the FAQ for the Challenging Conversations Toolkit, Pastor Church Resources notes that "The release of the Human Sexuality Report to Synod 2021 and its subsequent discussion, deliberation, and response represent an enormous challenge for Christians, local congregations, classes, and the entire Christian Reformed Church." The enormity is further outlined when the FAQ goes on to note that, "Many wonder if our denomination and congregations have the appetite to endure the kind of struggle and pain that accompanied previous disagreements. Some wonder if we ought to just skip the conversation and jump directly to an orderly separation or realignment."4
- 4. Any overtures submitted would be considered at a Synod that, by most predictions, will be primarily virtual for the first time in Synod's history. Solely virtual discussion is difficult on any topic, but particularly so on many aspects of this report. Communal worship and table fellowship at shared meals and coffee breaks are important parts of Synod, as they are critical parts of dialoguing well as the Body of Christ, and this is all the truer when the topics of formal discussion are as contentious as the ones in this report.
- 5. Further time would allow for prayerful and deliberate discussion and discernment among churches, let councils and classes collect thorough feedback from congregation members, give proper opportunity to study the impact or clarify the meaning of various recommendations in the report, and give space for church leadership to attend well pastorally to the impact these discussions will have on those involved.

### Classis BC Northwest – March 2021 Overture / Communications Advisory Committee Report

#### **Materials:**

Overture regarding Neland Avenue CRC in Grand Rapids MI: New Westminster CRC

#### **Recommendation:**

We are sympathetic to the distress experienced by the Council of New Westminster CRC regarding the ordination of an individual involved in a same-sex marriage. However, CRCNA church polity does not allow Synod to discipline a council unless appealed to do so from a member of the congregation in question. For this reason, the advisory committee recommends Classis send a communication of concern to Neland Avenue CRC and Synod.

#### **Grounds:**

1. Decisions of synod are binding unless proved to be in conflict with the Word of God or the Church Order (Church Order Article 29). All members and office bearers are expected to abide by them. Yet there are differences in types of synodical decisions, and consequent differences in expected compliance. Synod 1975 delineated the difference between decisions declared to be interpretations of the confessions (which we must affirm), and decisions proffered as pastoral advice to the churches. The latter are decisions with which members and office bearers may respectfully disagree. Past Synod's decisions on homosexuality and same-sex marriage in 1973, 2002 and 2016 have the status of pastoral advice.

The *Manual of CRC Government* says the following about the 2016 decision on the issue of same-sex marriage and pastoral advice: "Synod 2016 struggled at length to decide how best to respond to the majority and minority study committee reports dealing with same-sex marriage



issues. Ultimately synod decided to receive both reports as information and then also decided to recommend that the churches consider the *pastoral guidance* contained in the minority report. It is important to take note that Synod 2016 recommended only the pastoral guidance to the churches. Local consistories ultimately are responsible for the manner in which pastoral care is provided in individual situations. Synod deals only with pastoral or disciplinary matters in local congregations upon appeal. It may be tempting for some to cite Synod 2016's recommendation of pastoral guidance as a synodically mandated position, but the administration of pastoral care and discipline is clearly within the domain of the local church. Therefore, as the Supplement [to Church Order Article 69-c] clearly states, the synodical recommendation "represents one example of how synod has determined that a marriage is considered to be in conflict with the Word of God." (240).

- 2. It must be noted, Neland Ave. CRC has done more than disagree with pastoral advice on same-sex marriage. They have taken an action in direct opposition to that position in ordaining a same-sex married person. However, Synod is unable to directly discipline Nelson Ave. CRC unless the matter reaches Synod via an appeal process which must begin with the congregation of Nelson Ave. CRC, continue through Classis Grand Rapids East, and on to Synod. If Classis Grand Rapids East did not accede to such an overture, the Neland Avenue CRC member could overture Synod directly.
- 3. Synod 2015 reinforced the grounds that synods could not be able to directly discipline Neland Ave. CRC apart from the route articulated in item #3. When asked to discipline churches in Classis Grand Rapids East for support of an advocacy group for LGBTQ+ members, Synod 2015 said in the *Acts of Synod 2015*, p. 674: "Synod cannot instruct a classis or a council to exercise discipline, except upon appeal (one consistory cannot ask another consistory to act as its proxy in matters of discipline, as indicated in decisions of Synod 1988, *Acts of Synod 1988*, p. 613). The discipline of church members is the responsibility of the local council (see Church Order Articles 37, 78-81, 85)." The aforementioned reference to Synod 1988 says this: "When a *consistory* [now called *council*] judges that it has sufficient grounds of suspicion against an office-bearer not under its supervision, it may communicate such to that office-bearer's consistory or the synodical board under which the office-bearer serves. If the office-bearer's consistory and/or synodical board then judges that the grounds of suspicion are insufficient to require further explanation, the procedure ends. If the suspicions or concerns are judged valid, the consistory must follow the regulations of the Church Order Article 83." 1

#### **Proposed Communication:**

Classis BC Northwest communicates to Synod its dismay at and concern for Neland Avenue CRC's decision to ordain an individual to the Office of Deacon who is involved in a same-sex marriage and desires for Neland Avenue CRC to return to the bounds of Scripture, our Confessions, and the position of our denomination on same-sex marriage as stated in the 1973 Report on Homosexuality.



#### **Grounds:**

- 1. An office-bearer holds that office within the denomination and not merely in alocal congregation or Classis.
- 2. Neland Avenue CRC has taken action contradictory to the position of the CRCNA which is rooted in Biblical understanding of marriage as a covenant between a man and a woman.
- 3. Neland Avenue CRC proceeded with its actions prior to the release of and Synod's response to the denomination's Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality.

We also affirm three confessions—the Belgic Confession, the Heidelberg Catechism, and the Canons of Dort—as historic Reformed expressions of the Christian faith, whose doctrines fully agree with the Word of God. These confessions continue to define the way we understand Scripture, direct the way we live in response to the gospel, and locate us within the larger body of Christ.

Grateful for these expressions of faith, we promise to be formed and governed by them. We heartily believe and will promote and defend their doctrines faithfully, conforming our preaching, teaching, writing, serving, and living to them.

Along with these historic creeds and confessions, we also recognize the witness of Our World Belongs to God: A Contemporary Testimony as a current Reformed expression of the Christian faith that forms and guides us in our present context.

We also promise to present or receive confessional difficulties in a spirit of love and fellowship with our brothers and sisters as together we seek a fuller understanding of the gospel. Should we come to believe that a teaching in the confessional documents is not the teaching of God's Word, we will communicate our views to the church, according to the procedures prescribed by the Church Order and its supplements. If the church asks, we will give a full explanation of our views. Further, we promise to submit to the church's judgment and authority.

We honor this covenant for the well-being of the church to the glory of God the Father, Son, and Holy Spirit.

\*The Covenant for Officebearers is signed by each officebearer at the time of installation into office in a local congregation, or the first time a person is delegated to a meeting of a classis. (CO Art. 5, Commentary)
